Old Business

- A. Post public hearing statement on proposed amendments to **Chapter 16-88, HAR, "Relating to Naturopaths**, implementing Act 22, Special Session 2009; effectuating the use of parenteral therapy and the performance of minor office procedures by naturopathic physicians. (DCCA)
- B. Update on the status of nominees to the Small Business Regulatory Review Board (Staff)

New Business

- A. Proposed repeal of Chapter 15-22, HAR, and adoption of Chapter 15-217, HAR, "Relating to the Kakaako Community Development District Mauka Area," which proposes to enhance the public areas, promote economic development and incorporate best practices in energy and environmental sustainability and Chapter 15-218, HAR, "Relating to Kakaako Reserved Housing," which proposes to require new residential projects on lots measuring at least 20,000 square feet to provide reserved housing. - B. Proposed repeal of Chapter 15-200, HAR, "Rules for Health and Safety within the Kalaeloa Community Development District," and adoption of Chapter 15-215, HAR, "Kalaeloa Community Development District Rules" and Chapter 15-216, HAR, "Kalaeloa Community Development District Reserved Housing Rules," which establishes new zoning rules for all development within the Kalaeloa Community Development District. (DBEDT/HCDA)
- C. Chu Lan Schubert-Kwock's application to fill an Oahu vacancy on the Board.
- D. Legislative update – HB980 HD1 & SB1498, "Relating to the Small Business Regulatory Review Board.

- A. Post public hearing statement of proposed amendments to **Chapter 12-12-60, 12-61 and 12-63, HAR, "Prepaid Health Care Act"**, which eliminates the requirement for employers and health care insurance plan contractors to submit reports and forms to the Director on an annual basis. (DLIR)

Post public hearing statement of proposed amendments to **Chapter 12-10, HAR, "Workers' Compensation Law"**; **Chapter 12-14-36, HAR, "Vocational Rehabilitation Rules"**, in response to Hawaii Supreme Court decision which held that the Director exceeded the bounds of rule-making authority; and **Chapter 12-15, HAR, "Workers' Compensation Medical Fee Schedule"**, which requires the Director to update the schedules every three years or annually, as required. (DLIR)
