THE COMMISSION ORDERS:


1. The Parties' Revised Stipulated Procedural Schedule, attached as Exhibit 1, is approved.

2. The deadlines set forth in the attached Revised Stipulated Procedural Schedule shall be utilized in this docket, unless otherwise ordered by the commission.




STIPULATED PROCEDURAL SCHEDULE




