## **Commissioner's Message**

Dear Governor Lingle and Director Recktenwald:

It is my privilege to submit to you the 2004 Annual Report and Directory of State-Chartered Financial Institutions compiled by the Division of Financial Institutions (“DFI”).

During 2004 the DFI continued to fulfill its traditional mission of ensuring the safety and soundness of the State of Hawaii’s financial services industry.

Although the number of State chartered financial institutions continues to decline, their size, product diversity and technological complexity present significant regulatory and supervisory challenges which have broadened the scope of the traditional financial service examination and administration process. Expanded supervision of the escrow depository and financial service loan company licensees, driven in part by the increased demands of Federal Bank Secrecy Act related activities, has resulted in new demands on examiner training and scheduling. Other areas of possible DFI involvement such as money transmitters, check cashers, mortgage brokers and payday lenders are being evaluated as a part of the legislative process. The addition of some of these industries may require additional staff, training and infrastructure commitments.

DFI and its regulatory partners, the Federal Reserve Bank, the Federal Deposit Insurance Corporation (“FDIC”) and the National Credit Union Administration continue to work closely together to provide a seamless supervision and examination framework for all of our State-chartered institutions. Conducting joint examinations with our Federal regulatory colleagues also contributes to improvement in DFI staff proficiency and professionalism. As international events have an impact on the local financial community, DFI has continued to develop and maintain lines of communication with our fellow Pacific Island and Asian regulators. We look forward to expanding these relationships going forward.

DFI staff keeps pace with changes in both law and process through specialty educational opportunities such as the FDIC’s State Examiner Training Program, and internet based lessons provided by the Conference of State Bank Supervisors (“CSBS”), our regulatory trade association. This has helped address staff turnover issues and allowed our recently hired examiners to develop new abilities and sharpen existing skills.

The key to any successful organization is the people who work within it. The DFI staff, from its most seasoned veteran to its newest examiner in training, has been and will continue to be that key component. It is therefore appropriate to not only thank them here for their past hard work, but to acknowledge their continuing critical importance in the division’s ability to meet its future objectives.

We are all looking forward to meeting 2005’s new challenges while continuing to fulfill traditional statutory responsibilities related to protecting consumers and ensuring the safety and soundness of the State of Hawaii’s financial services industry.
