THE REPORT REFLECTS INFORMATION DISCLOSED IN THE REQUIRED NOTICE OF INTENTION SUBMITTED MAY 9, 1974, AND ADDITIONAL INFORMATION SUBSEQUENTLY FILED AS OF JULY 16, 1974. THE DEVELOPER, BY NOTIFYING THE COMMISSION OF ITS INTENTION TO SELL, IS COMPLYING WITH THE REQUIREMENTS OF THE HORIZONTAL PROPERTY ACT, CHAPTER 514, HAWAII REVISED STATUTES, AS AMENDED.

1. Since the issuance of the Commission's Preliminary Public Report of May 17, 1974, the Developer reports that changes have been made in the plan or setup as presented in the May 9, 1974 notice of intention to sell. The changes subsequently made are determined to be a material revision to the information disclosed earlier.

This Final Public Report (white paper stock) amends the Makakilo Hale I (Phase I) Preliminary Public Report (yellow paper stock), becoming a part of this registration. The Developer is responsible for placing a true copy of this Final Public Report in the hands of all purchasers and prospective purchasers, along with a copy of the Preliminary Public Report. The buyer shall sign the required receipt signifying that he has had an opportunity to read both reports.

2. The Developer of the project has submitted to the Commission for examination all documents deemed necessary for the registration of a condominium project and the issuance of this Final Public Report.
3. The basic documents (Declaration of Horizontal Property Regime of Makakilo Hale I, By-Laws of Association of Apartment Owners of Makakilo Hale I, and a copy of the floor plans) have been filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii.

The Declaration of Horizontal Property Regime of Makakilo Hale I, with By-Laws of the Association of Apartment Owners of Makakilo Hale I, dated July 12, 1974 were filed in said Office as Document No. 689634 and noted on Transfer Certificate of Title No. 164,413.

The Assistant Registrar has designated Condominium Map No. 221 to the project.

4. Advertising and promotional matter have been submitted to the Commission.
5. The purchaser or prospective purchaser is advised to acquaint himself with the provisions of Chapter 514, Hawaii Revised Statutes, and the Condominium Rules and Regulations which relate to horizontal property regimes.
6. This Final Public Report automatically expires thirteen (13) months after the date of issuance, July 16, 1974, unless a Supplementary Public Report issues or the Commission, upon review of the registration, issues an order extending the effective period of this report.

The information in the topical headings of the Preliminary Public Report of May 17, 1974, with the exception of ENCUMBRANCES AGAINST TITLE and STATUS OF THE PROJECT, has not been disturbed.

ENCUMBRANCES AGAINST TITLE: A Preliminary Report dated June 12, 1974, prepared by Security Title Corporation, certifies that the land is subject to the following encumbrances:

1. Tax Key: 9-2-3-64 (por.) - Area Assessed: 5,089.550 Acres

Taxes for the Fiscal Year 1973-1974 are a lien; payable as follows:

(The land comprising the project is Lot 2537, area 9.371 acres.)

2. Designation of Easement 728 (Map 233) for sewer purposes affecting Lot 2537, as set forth in Land Court Order No. 38745, filed November 26, 1973.
3. Development Rights dated May 5, 1966, filed in the Office of the Assistant Registrar of the Land Court of the State of Hawaii as Document No. 391241, made by and between the TRUSTEES UNDER THE WILL AND OF THE ESTATE OF JAMES CAMPBELL, DECEASED, Owners, and FINANCE REALTY CO., LTD., a Hawaii corporation, Developer.

Said Development Rights is encumbered by the following:

- a. Mortgage dated July 13, 1972, filed in said Office of the Assistant Registrar as Document No. 589482, made by FINANCE REALTY CO., LTD., a Hawaii corporation, as Mortgagor, to BANK OF HAWAII, a Hawaii corporation, as Mortgagee, to secure the repayment of the sum of \$4,700,000.00, any additional advances and other amounts secured thereby, all according to the terms of that certain promissory note of said mortgagor therein referred to. Consent thereto filed as Document No. 589483.
- b. Additional Charge Mortgage dated December 5, 1973, filed in said Office of the Assistant Registrar as Document No. 660310, made by FINANCE REALTY COMPANY, LTD., a Hawaii corporation, as Mortgagor, to BANK OF HAWAII, a Hawaii corporation, as Mortgagee, to secure the repayment of the additional loan of \$1,000,000.00, together with interest thereon all according to the terms of that certain promissory note therein referred to. This is an additional charge mortgage to the foregoing mortgage. (besides other land) Consent thereto filed as Document No. 660311.
4. Undated Financing Statement recorded on December 11, 1973 in the Bureau of Conveyances of the State of Hawaii in Book 9638 Page 193, to which reference is hereby made.
5. The terms and provisions of that certain Lease dated March 18, 1974, filed in said Office of the Assistant Registrar as Document No. 682961, made by and between TRUSTEES UNDER THE WILL AND OF THE ESTATE OF JAMES CAMPBELL, DECEASED, as Lessors, and HAWAIIAN ELECTRIC COMPANY, INC., a Hawaii corporation, as Lessee, for the term of 55 years commencing March 18, 1974 and continuing thereafter for so long as electrical service is required from the lines and appurtenances within Lot 2537. Said Lease demises a right and easement for transformer vaults and underground power lines over and across Lot 2537. Consent thereto filed as Document No. 682962.

NOTE: The Developer had advised the Commission that the fee simple landowner, the Trustees under the Will and of the Estate of James Campbell, Deceased, has granted to the Developer, for and on behalf of the Association of Apartment Owners of Makakilo Hale I, and for and on behalf of all owners of apartments in Makakilo Hale I, easements for drainage and flowage purposes, the grant of such easements being dated June 10, 1974, and filed in said Office of the Assistant Registrar as Document No. 689637. As the Association of Apartment Owners of Makakilo Hale I and all owners of

apartments in Makakilo Hale I are indemnifying the Trustees against all claims and demands for loss or damages, including property damage, personal injury and wrongful death, arising out of or in connection with the use of the drainage facilities, easement areas, and adjacent areas by the said Association and apartment owners or any person claiming by, through or under said Association and apartment owners, purchasers in this project should familiarize themselves with the provisions of the abovementioned grant.

STATUS OF THE PROJECT: The Developer advises that it has completed all fourteen of the two-story multi-family buildings in Makakilo Hale I (Phase I). All construction of Makakilo Hale I (Phase I) has been with funds from a Bank of Hawaii revolving line of credit and without the use of any portion of the purchase money paid by purchasers of the apartments in the project. A condition of the disbursement of escrow funds is the issuance of this Final Public Report.

The purchaser or prospective purchaser should be cognizant of the fact that this published report represents information disclosed by the Developer in the required Notice of Intention submitted May 9, 1974, and additional information subsequently filed as of July 16, 1974.

This FINAL HORIZONTAL PROPERTY REGIMES (CONDOMINIUM) PUBLIC REPORT is made a part of REGISTRATION NO. 682 filed with the Commission May 9, 1974.
