**Summary of Changes from Earlier Public Reports:**

This summary contains a general description of the changes, if any, made by the developer since the last public report was issued. It is not necessarily all inclusive. Prospective buyers should compare this public report with the earlier reports if they wish to know the specific changes that have been made. The "last public report" for recipients of this Supplementary Public Report is the amended Final Public Report for Alii Lani Phase 1F, dated December 22, 2000, Reg. No. 4439. The Preliminary Public Report for Alii Lani Phase 1G, dated December 12, 2000, Reg. No. 4525 is hereby rescinded.

No prior reports have been issued by the developer.

Changes made are as follows:

1. **Additional Apartments.** Pursuant to rights reserved to the Developer in the Declaration of Condominium Property Regime of Alii Lani Phase 1F (the "Declaration"), the Developer has added the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV, which were originally intended to be part of Alii Lani Phase 1G, to the Alii Lani Phase 1F condominium project (the "Project"). The Project originally consisted of the 80 apartments in Buildings BB, CC, DD, EE, JJ, LL, MM, QQ and RR. Sales of those 80 apartments by the Developer to individual purchasers have been and continue to be covered by the original final public report for the Project, which is a separate document and has an effective date of December 22, 2000. The Project now consists of those original 80 apartments and the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV. **This Supplementary Final Public Report covers only the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV and, accordingly, sales of those 55 apartments are covered herein.**
2. **Building PP renamed Building VV.** Building PP has been renamed Building VV. As such, all apartments in that building are now referred to with the new VV designation. For example, Apartment PP101 is now Apartment VV101.
3. **Previous Preliminary Public Report.** The 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV were previously covered by a Preliminary Public Report for Alii Lani Phase 1G (Registration No. 4525), which had an effective date of December 12, 2000. As stated above, the Developer has decided to add those 55 apartments to the Alii Lani Phase 1F Project, rather than make them part of a separate Alii Lani Phase 1G condominium project. As a result, there will be no Alii Lani Phase 1G condominium project and the Preliminary Public Report for Alii Lani Phase 1G has been superseded by this Supplementary Public Report. Sales of the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV are now covered by this Supplementary Public Report.
4. **Declaration.** The Declaration of Condominium Property Regime of Alii Lani Phase 1F dated November 13, 2000, and recorded in the Bureau of Conveyances of the State of Hawaii (the "Bureau") as Document No. 2000-159558 (the "Declaration"), and Condominium Map No. 3185 (the "Condominium Map") have been amended twice. The First Amendment to Declaration of Condominium Property Regime of Alii Lani Phase 1F and Amendment to Condominium Map No. 3185 dated February 23, 2001, and recorded in the Bureau as Document No. 2001-029772, substituted certain parking stalls that were appurtenant to certain apartments in Alii Lani Phase 1F with an equivalent number of other parking stalls, corrected the parking stall assignments for Apartments EE103, EE104, EE203, EE204, JJ101, JJ103, JJ104, JJ201, JJ203 and JJ204 and corrected the locations of those apartments on the Condominium Map. The Second Amendment to Declaration of Condominium Property Regime of Alii Lani Phase 1F and Amendment to Condominium Map No. 3185 dated February 26, 2001, and recorded in the Bureau as Document No. 2001-029773, amended the Declaration and the Condominium Map to add the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV to the Project.
5. **Common Interests.** As a result of adding the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV to the Project and in accordance with the Declaration, the common interests of the apartments have been adjusted. The Declaration has been amended to reflect the adjustment in the common interests. EXHIBIT "E" to this public report shows the current common interest for each of the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV.

6. Common Expenses/Maintenance Fees. As a result of adding the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV to the Project and the adjustment in the common interests of the apartments, the estimated maintenance fee disbursements for the Project and the estimate of initial maintenance fees for the apartments has been revised. EXHIBIT "G" to this public report shows the current estimate of initial maintenance fees for each of the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV and the estimated maintenance fee disbursements for the Project as a whole.
7. Revised Apartment Type Designation. Those apartments previously designated in the preliminary public report for Alii Lani Phase 1G as Type D apartments are now designated as Type D-1 apartments. Other than the change in the designation reference, the apartments are the same.
8. Amendment to Escrow Agreement. The Escrow Agreement was amended to allow, under certain circumstances and as permitted by the Condominium Property Act, Chapter 514A, Hawaii Revised Statutes, the purchaser's funds to be disbursed by the Escrow Agent prior to completion of construction of the apartment and/or prior to closing of the purchase.
9. Parking Stall Assignments. The parking stall designations for many of the apartments in Building KK have changed from what was reported in the preliminary public report covering the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV. See Exhibit "B" to this public report for a complete and current assignment of parking stalls for those apartments.
10. Amendment to Sales Contract. Buyers of apartments in Buildings FF, GG, HH, KK, NN, OO and VV will be given an amendment to their Deposit Receipt, Reservation and Sales Contract. The amendment will explain that the apartment they are buying has been added to Alii Lani Phase 1F and that all references to Alii Lani Phase 1G are replaced with references to Alii Lani Phase 1F.
11. Revised Apartment Deed. The specimen Apartment Deed for Alii Lani Phase 1G has been revised so that all references to Alii Lani Phase 1G were replaced with references to Alii Lani Phase 1F. The revised Apartment Deed will be used for buyers of apartments in Buildings FF, GG, HH, KK, NN, OO and VV.
12. Estimated Date of Completion of Construction. The Developer estimates that construction of the Project will be completed in approximately October 2001.

## **General Information On Condominiums**

A condominium is a special form of real property. To create a condominium in Hawaii, the requirements of the Condominium Property Act, Chapter 514A, Hawaii Revised Statutes, must be complied with. In addition, certain requirements and approvals of the County in which the project is located must be satisfied and obtained.

Some condominium projects are leasehold. This means that the land or the building(s) and other improvements are leased to the buyer. The lease for the land usually requires that at the end of the lease term, the lessees (apartment owner/tenants) deliver their interest in the land to the lessor (fee property owner). The lease also usually requires that the lessees either (1) convey to the lessor the building(s) and other improvements, including any improvements paid for by the lessees; or (2) remove or dispose of the improvements at the lessee's expense. Leases for individual apartments often require that at the end of the lease term, the lessee deliver to the lessor the apartment, including any improvements placed in the apartment by the lessee.

If you are a typical condominium apartment owner, you will have two kinds of ownership: (1) ownership in your individual apartment; and (2) an undivided interest in the common elements.

"Common elements" are the areas of the condominium project other than the individual apartments. They are owned jointly by all apartment owners and include the land, either in fee simple or leasehold, and those parts of the building or buildings intended for common use such as foundations, columns, roofs, halls, elevators, and the like. Your undivided interest in the common elements cannot be separated from ownership of your apartment.

In some condominium projects, some common elements are reserved for the exclusive use of the owners of certain apartments. These common elements are called "limited common elements" and may include parking stalls, patios, lanais, trash chutes, and the like.

You will be entitled to exclusive ownership and possession of your apartment. Condominium apartments may be individually bought, sold, rented, mortgaged, or encumbered, and may be disposed of by will, gift, or operation of law.

Your apartment will, however, be part of the group of apartments that comprise the condominium project. Study the project's Declaration, Bylaws, and House Rules. These documents contain important information on the use and occupancy of apartments and the common elements as well as the rules of conduct for owners, tenants, and guests.

## **Operation of the Condominium Project**

The Association of Apartment Owners is the entity through which apartment owners may take action with regard to the administration, management, and operation of the condominium project. Each apartment owner is automatically a member of the Association.

The Board of Directors is the governing body of the Association. Unless you serve as a board member or an officer, or are on a committee appointed by the board, your participation in the administration and operation of the condominium project will in most cases be limited to your right to vote as an apartment owner. The Board of Directors and officers can take certain actions without the vote of the owners. For example, the board may hire and fire employees, increase or decrease maintenance fees, borrow money for repair and improvements and set a budget. Some of these actions may significantly impact the apartment owners.

Until there is sufficient number of purchasers of apartments to elect a majority of the Board of Directors, it is likely that the developer will effectively control the affairs of the Association. It is frequently necessary for the developer to do so during the early stages of development and the developer may reserve certain special rights to do so in the Declaration and Bylaws. Prospective buyers should understand that it is important to all apartment owners that the transition of control from the developer to the apartment owners be accomplished in an orderly manner and in a spirit of cooperation.

**II. CREATION OF THE CONDOMINIUM;  
CONDOMINIUM DOCUMENTS**

A condominium is created by recording in the Bureau of Conveyances and/or filing with the Land Court a Declaration of Condominium Property Regime, a Condominium Map (File Plan), and the Bylaws of the Association of Apartment Owners. The Condominium Property Act (Chapter 514A, HRS), the Declaration, Bylaws, and House Rules control the rights and obligations of the apartment owners with respect to the project and the common elements, to each other, and to their respective apartments. The provisions of these documents are intended to be, and in most cases are, enforceable in a court of law.

A. **Declaration of Condominium Property Regime** contains a description of the land, buildings, apartments, common elements, limited common elements, common interests, and other information relating to the condominium project.

D. **House Rules.** The Board of Directors may adopt House Rules to govern the use and operation of the common elements and limited common elements. House Rules may cover matters such as parking regulations, hours of operation for common facilities such as recreation areas, use of lanais and requirements for keeping pets. These rules must be followed by owners, tenants, and guests. They do not need to be recorded or filed to be effective. The initial House Rules are usually adopted by the developer.

**IMPORTANT INFORMATION ON LEASEHOLD CONDOMINIUM PROJECTS**

The information contained in this report is a summary of the terms of the lease. For more detailed information, you should secure a copy of the lease documents and read them thoroughly.

If you have any legal questions about leasehold property, the lease documents or the terms of the lease and the consequences of becoming a lessee, you should seek the advice of an attorney.

There are currently no statutory provisions for the mandatory conversion of leasehold condominiums and there are no assurances that such measures will be enacted in the future.

In leasehold condominium projects, the buyer of an apartment will acquire the right to occupy and use the apartment for the time stated in the lease agreement. The buyer will not acquire outright or absolute fee simple ownership of the land. The land is owned by the lessor or the leased fee owner. The apartment owner or lessee must make lease rent payments and comply with the terms of the lease or be subject to the lessor's enforcement actions. The lease rent payments are usually fixed at specific amounts for fixed periods of time, and are then subject to renegotiation. Renegotiation may be based on a formula, by arbitration set in the lease agreement, by law or by agreement between the lessor and lessee. The renegotiated lease rents may increase significantly. At the end of the lease, the apartment owners may have to surrender the apartments, the improvements and the land back to the lessor without any compensation (surrender clause).

When leasehold property is sold, title is normally conveyed by means of an assignment of lease, the purpose of which is similar to that of a deed. The legal and practical effect is different because the assignment conveys only the rights and obligations created by the lease, not the property itself.

The developer of this condominium project may have entered into a master ground lease with the fee simple owner of the land in order to develop the project. The developer may have then entered into a sublease or a new lease of the land with the lessee (apartment owner). The developer may lease the improvements to the apartment owner by way of an apartment lease or sublease, or sell the improvements to the apartment owners by way of a condominium conveyance or apartment deed.

The Developer will require from the general contractor for the Project a written warranty with respect to any defects in each apartment and the common elements due to faulty materials and/or workmanship which are discovered and reported within one year from the "Date of Substantial Completion" as defined in the construction contract. The Developer makes no warranties itself; however, the Developer will attempt to assign to each apartment owner any and all warranties given the Developer by the general contractor for the project and by any subcontractors or materialmen.

2. Appliances:

The Developer makes no warranties itself; however, the Developer will attempt to assign to each apartment owner the benefit of any manufacturer's or dealer's warranties covering the appliances in his or her apartment. Each apartment owner shall have the direct benefit of any such warranties. These warranties will expire at different times, depending on the date of manufacture, sale or installation of the appliances.

**G. Status of Construction and Date of Completion or Estimated Date of Completion:**

Construction of the 55 apartments in Buildings FF, GG, HH, KK, NN, OO and VV began in January, 2001, and is anticipated to be completed by approximately October, 2001.

**H. Project Phases:**

Merger: The Developer has reserved the right, in its sole and absolute discretion, to merge this Project with other condominium projects (including Alii Lani (comprised of the former Alii Lani Phase 1A, Alii Lani Phase 1B, Alii Lani Phase 1C, Alii Lani Phase 1D and Alii Lani Phase 1E projects, which were merged for ownership purposes), developed by the Developer on land adjacent to the Project land) for purposes of use and administration and possibly ownership, as provided in the Declaration of Merger of Condominium Phases Alii Lani, recorded in the Bureau of Conveyances of the State of Hawaii as Document No. 96-010538, as may be amended from time to time (the "Declaration of Merger"). Pursuant to an "administrative merger," use of the common elements, the common expenses and management of the phases would be shared, but the ownership interests of the apartment owners in each phase would not be altered or affected. In other words, an apartment owner owning an apartment in Alii Lani Phase 1F, while having the right to use the common elements (including the recreational facilities) of other merged phases, would not have an ownership interest in the other merged phases. Similarly, the owner of an apartment in another merged phase, while having the right to use the common elements of the Project, would not have an ownership interest in the common elements of the Project. An "ownership merger", on the other hand, would provide for the common ownership of all of the merged phases. Upon an ownership merger, all of the apartments in the merged phases would be treated as if they were all included in a single condominium project (the "merged project"), all common elements of the merged phases would become common elements of the merged project, and the common interest appurtenant to each apartment would be altered from the common interest set forth in Exhibit E to the common interest set forth in a "certificate of ownership merger," as provided in the Declaration of Merger. An ownership merger may also include a legal consolidation of the land underlying and included in Alii Lani Phase 1F with any parcel(s) of land underlying and included in any of the additional phases. Each prospective purchaser should carefully review the applicable provisions of the Declaration of Condominium Property Regime and the Declaration of Merger regarding the rights reserved to the Developer relating to development in phases and the merger of such phases. B) The buyer is given an opportunity to read the report(s); **AND**

C) One of the following has occurred:

- 1) The buyer has signed a receipt for the report(s) and waived the right to cancel; or
- 2) Thirty (30) days have passed from the time the report(s) were delivered to the buyer; or
- 3) The apartment is conveyed to the buyer within 30 days from the date the report(s) were delivered to the buyer.

Material Change: Binding contracts with the Developer may be rescinded by the buyer if:

- A) There is a material change in the project which directly, substantially, and adversely affects (1) the use or value of the buyer's apartment or its limited common elements; or (2) the amenities available for buyer's use; **AND**
- B) The buyer has not waived the right to rescind.

If the buyer rescinds a binding sales contract because there has been a material change, the buyer is entitled to a full and prompt refund of any moneys the buyer paid.

C. Additional Information Not Covered Above

ARCHAEOLOGICAL SITES

Archaeological site HRHP 14409 (a possible burial site) is located on land adjacent to the Project, being part of Alii Lani and is subject to an archaeological preservation plan approved by the Hawaii Historic Places Review Board of the Department of Land and Natural Resources (the "DLNR"), State of Hawaii. In the event of a merger with Alii Lani, the Association will have certain obligations relating to preservation of the archaeological site, as set forth in the archaeological preservation plan. The archaeological preservation plan for HRHP 14409 includes the following:

HRHP 14409 - The platform will be preserved and restored to its state prior to the archaeological excavations. This includes a replacement of the fill rocks to the original configuration of the platform.

The perimeter of the site shall be identified by two existing stone walls situated on the south and east sides of the site and the creation of two other walls on the north and west sides of the site.

The surveyed perimeter of the site shall serve as the permanent No Excavation/No Construction buffer to HRHP 14409. The stone walls shall be built to a height of approximately three feet as measured from the natural base elevation adjacent to the burial platform. The stone wall will be constructed with natural rocks and a limited amount of mortar in order to provide adequate stability and security to the site. Native Hawaiian shrubbery shall be planted around the perimeter of the site and a sign with the word "Kapu" will be affixed to the stone wall which encloses the site.

Archaeological site HRHP 14432 (a possible burial site) is located on land adjacent to the Project and is subject to an archaeological preservation plan approved by the Hawaii Historic Places Review Board of the DLNR. In the event of a merger with Alii Lani, the Association will have certain obligations relating to preservation of the archaeological site, as set forth in the archaeological preservation plan. The archaeological preservation plan for HRHP 14432 includes the following:

The test pit located on the far east side of the site shall be backfilled and restored to its original condition. The stone terrace area and natural terrain delineated by a radius of ten feet from the center of the aforementioned easterly test pit shall be preserved. Fill material shall then be used to cover the area.

A No Excavation/No Construction buffer consisting of the area identified by the ten foot radius shall then be imposed. The buffer zone shall be identified in accordance with the engineering survey conducted by Wes Thomas and Associates dated March 19, 1994.

Landscaping shall consist of a Hala tree which shall be planted directly above the burial.

A copy of the archaeological preservation plan for archaeological sites HRHP 14409 and HRHP 14432 is on file with the Real Estate Commission.

PROPERTY TAXES

The estimates of maintenance fees set forth in Exhibit G to this public report (dated February 8, 2001) do not include each apartment owner's obligation for payment of real property taxes. Property taxes will be directly payable by each apartment owner based upon the assessed value of the owner's apartment.

TEMPORARY ACCESS DRIVEWAY

Item 3 of Exhibit F (Encumbrances Against Title) to this public report is a Unilateral Agreement dated July 6, 1995 and recorded in the Bureau of Conveyances of the State of Hawaii as Document No. 95-092935 (the "Unilateral Agreement"). The Unilateral Agreement was made by the Developer in favor of the County of Hawaii (the "County") in connection with the County's approval of the development plans for the Alii Lani condominium project (the "Alii Lani Project"). The Memorandum of Agreement (the "Memorandum") attached to the Unilateral Agreement requires the Developer to construct a temporary access driveway within the Alii Lani Project to the Alii Parkway, which, in 1995, was proposed to be built adjacent to the mauka boundary of the Alii Lani Project. It appears that the 12-foot wide temporary access driveway would only have to be built if the Alii Parkway is, in fact, constructed adjacent to the mauka boundary of the Alii Lani Project. Current design plans for the proposed Alii Parkway do not show the Alii Parkway adjacent to the Alii Lani Project. If the temporary access driveway is ever built, the Memorandum



requires that it be built in the vicinity of those buildings that have been designated by the Developer as Building U (which is part of Alii Lani) and Building QQ (which is part of this Alii Lani Phase 1F project). If built, the temporary access driveway would run between Building U and Building QQ to the mauka boundary of the Alii Lani Project. During its use, such a driveway would likely result in increased vehicular traffic in the vicinity of Buildings U and QQ. The Memorandum also requires that the temporary access driveway be closed within 30 days of the opening of the permanent mauka-makai driveway that would be built adjacent to the northern boundary of the Alii Lani Project, from Alii Drive to the proposed Alii Parkway. The Developer has made provisions for the construction of the temporary access driveway between Buildings U and QQ, if it is needed. However, because the Alii Parkway may not be built at all and, if built, may not be built adjacent to the mauka boundary of the Alii Lani Project, thereby alleviating the need for the temporary access driveway, the Developer does not plan to construct the temporary access driveway at this time. Nevertheless, if required, the Developer shall have the right to construct the temporary access driveway as described above and contemplated in the Memorandum.

- D. The developer hereby declares, subject to the penalties set forth in section 514A-49(b), that the Project is in compliance with all county zoning and building ordinances and codes, and all other county permitting requirements applicable to the Project, pursuant to Act 251 (SLH 2000).
- E. The developer hereby certifies that all the information contained in this Report and the Exhibits attached to this Report and all documents to be furnished by the developer to buyers concerning the project have been reviewed by the developer and are, to the best of the developer's knowledge, information and belief, true, correct and complete.

**EXHIBIT A**

DESCRIPTION OF BUILDINGS

The portion of the Project covered by this report shall contain seven residential apartment buildings, all of which shall contain eight apartments, except that Building FF contains seven apartments. Each such apartment building shall have two stories or levels. The Alii Lani Phase 1F Project shall also contain two recreation buildings, which are both one story and contain no apartments. One recreation building contains an exercise room and storage areas. The other recreation building contains restrooms, a pool equipment room and a storage room. None of the buildings shall have a basement. The buildings shall be constructed principally of concrete, wood, steel, glass and related building materials.

There shall be three different building types in the portion of the Project covered by this report. Those apartment types are designated as Building Types IA, V and VI. Each Building Type IA shall have eight apartments, all of which are Type D-1 apartments, except that Building FF shall have six Type D-1 apartments and 1 Type E apartment. Each Building Type V shall have eight apartments, all of which are Type B apartments. Each Building Type VI shall have eight apartments, four of which are Type B apartments and four of which are Type C apartments.

Each building is identified on the Condominium Map by a capital letter designation (for example "FF", "GG", "HH", "KK", "NN", "OO" or "VV"). The following is a list of all of the buildings in the Project covered by this report by building type and letter designation:

## EXHIBIT C

### COMMON ELEMENTS

The common elements of the Project shall specifically include, but are not limited to, the following:

1. The land described in Exhibit "A" to the condominium declaration, in fee simple.
2. All structural components, such as foundations, girders, columns, beams, floor slabs, supports, main walls, load-bearing walls, floors, ceiling (except the inner or decorated surfaces of such walls, floors and ceilings), roofs, exterior stairs and stairways, landings, railings (except lanai railings), entrances and exits of the buildings and/or apartments, and other building appurtenances, including, but not limited to, the electrical cabinets and compartments for water heaters located on the exteriors of the buildings.
3. All yards, grounds, gardens, planters, plants, landscaping, refuse facilities and recreational facilities, if any.
4. All sidewalks, pathways, driveways, roads, parking areas and parking stalls.
5. All ducts, electrical equipment, transformers, wiring, pipes and other central and appurtenant transmissions facilities and installations over, under and across the Project which are utilized by or serve more than one apartment for services such as power, light, water, gas, sewer, telephone and radio and television signal distribution, if any.
6. All areas, rooms, spaces, structures, housings, chutes, shafts or facilities of the Project within or outside of the buildings, which are for common use or which serve more than one apartment, such as electrical, maintenance, service, security, machine, mechanical and equipment rooms and the equipment, machinery and facilities therein.
7. The "Rec Center", including restrooms, showers, pool, spa and other facilities, located as shown on the Condominium Map.
8. All the benefits, if any, inuring to the land or to the Project from all easements, if any, shown on the Condominium Map or listed in Exhibit "A" to the condominium declaration.
9. Any and all apparatus and installations of common use and all other parts of the Project necessary or convenient to its existence, maintenance and safety, or normally in common use.
10. All other parts of the Project which are not included in the definition of an apartment.

## EXHIBIT D

### LIMITED COMMON ELEMENTS

Certain apartments shall have appurtenant thereto easements for the exclusive use of certain limited common elements as follows:

1. Parking Stalls:

Each apartment shall have appurtenant to it, as a limited common element, the exclusive right to use such parking stall(s) as designated on Exhibit "B" to this Public Report.

2. Water Heater Compartments:

Each compartment containing water heaters, and located adjacent to the entry area for each ground level apartment, is a limited common element appurtenant to the ground level apartment and to the second story apartment above it which are served by the water heaters contained in the compartment.

3. Entries:

The entry area outside the entry door of each apartment, as shown on the Condominium Map, is a limited common element appurtenant to that apartment.

4. Stairways and Second Floor Landings:

Each stairway and second floor landing area providing access to the entry areas for second floor apartments is a limited common element appurtenant to the apartments so served.

5. Mailboxes:

Each mailbox bearing the same identification as an apartment is a limited common element appurtenant to that apartment.

6. Yard Areas:

Each fenced-in yard area is a limited common element appurtenant to the first floor apartment which such yard area adjoins. The outer limit of each such yard area is deemed to be the interior surface of the fence (i.e., the surface facing the apartment) enclosing the area. **The size and dimensions of each such yard area, as shown on the Condominium Map, are approximate only; the Developer makes no representations or warranties whatsoever as to the size or dimensions of the yard area appurtenant to any particular apartment.**



## EXHIBIT H

### SUMMARY OF SALES CONTRACT

The Deposit Receipt, Reservation and Sales Agreement (the "Sales Contract") contains the price and other terms and conditions under which a purchaser will agree to buy an apartment in the Project. Among other things, the Sales Contract states:

(a) The total purchase price, method of payment and additional sums which must be paid in connection with the purchase of an apartment.

(b) That the purchaser acknowledges having received and read a public report (either preliminary, contingent, or final) for the Project prior to signing the Sales Contract.

(c) That the Developer makes no representations concerning rental of an apartment, income or profit from an apartment, or any other economic benefit to be derived from the purchase of an apartment.

(d) That the Sales Contract may be subordinate to the lien of a construction lender.

(e) That the purchaser's money will be held in escrow, under the terms of the Escrow Agreement.

(f) Requirements relating to the purchaser's financing of the purchase of an apartment.

(g) That the apartment and the Project will be subject to various other legal documents which the purchaser should examine, and that the Developer may change these documents under certain circumstances.

(h) That the Developer makes no warranties regarding the apartment, the Project or anything installed or contained in the apartment or the Project.

(i) That the Project will be subject to ongoing construction and sales activities which may result in certain annoyances to the purchaser.

(j) That the purchaser must close the purchase at a certain date and pay closing costs, in addition to the purchase price.

(k) That closing of the purchase may occur prior to issuance of the certificate of occupancy for the apartment, in which event the purchaser will not be able to possess or occupy the apartment until the certificate of occupancy has been issued.

(l) That the Developer has reserved certain rights and powers relating to the Project and the purchaser acknowledges and consents to the exercise of such rights and powers.

(m) That except under certain circumstances, as set forth in the Sales Contract, all interest on deposits toward the purchase price shall be the property of the Developer.

The Sales Contract contains various other important provisions relating to the purchase of an apartment in the Project. Purchasers and prospective purchasers should carefully read the specimen Sales Contract on file with the Real Estate Commission.

## EXHIBIT I

### SUMMARY OF ESCROW AGREEMENT

The Escrow Agreement sets up an arrangement under which the deposits a purchaser makes pursuant to a Sales Contract will be held by a neutral party ("Escrow"). Under the Escrow Agreement, these things will or may happen:

- (a) Escrow will let the purchaser know when payments are due.
- (b) Escrow will arrange for the purchaser to sign all necessary documents.
- (c) Except under certain circumstances as set forth in the Sales Contract, all deposits toward the purchase price shall be the property of the Developer.
- (d) The purchaser will be entitled to a refund of his or her funds only under certain circumstances as set forth in the Sales Contract.
- (e) Under certain circumstances, the purchaser's funds may be disbursed by escrow prior to completion of construction of the apartment and that the purchaser's deposits may be disbursed prior to closing of the purchase.

The Escrow Agreement also establishes the procedures for the retention and disbursement of a purchaser's funds and says what will happen to the funds upon a default under the Sales Contract. The Escrow Agreement contains various other important provisions and establishes certain charges with which a purchaser should be familiar. Purchasers and prospective purchasers should carefully read the signed Escrow Agreement on file with the Real Estate Commission.

## EXHIBIT J

### RESERVED RIGHTS

- A. Upon completion of the Project, the Developer may amend the Declaration and the Condominium Map (if necessary) to file an "as built" statement required by Section 514A-12 of the Condominium Property Act.
- B. Until all of the apartments have been sold, the Developer may amend the Declaration, the Bylaws and/or the Condominium Map to make such amendments as may be required by law, by the Real Estate Commission, by the title insurance company, by a mortgage lender, or by any governmental agency (including the VA, HUD, FNMA and/or FHLMC), provided that no such amendments change the common interest appurtenant to an apartment or substantially change the design, location or size of an apartment.
- C. Until all of the apartments have been sold and the "as built" statement is filed, the Developer may amend the Declaration and the Condominium Map to (i) reflect alterations in any apartment which has not been sold; and (ii) reflect minor changes in any apartment or in the common elements which do not affect the physical location, design or size of any apartment (other than minor changes to the size or dimensions of the yard area appurtenant to any apartment) which has been sold.
- D. The Developer may amend the Declaration to designate parking stalls not otherwise designated as limited common elements to be appurtenant to and for the exclusive use of any apartment in the Project or in any other phase merged or to be merged with the Project, or for use as guest stalls for the Project or any other phase merged or to be merged with the Project.

#### E. RESERVATION TO MERGE PHASES

The Developer has reserved the right, but is not obligated, to effect the merger of additional condominium projects (including Alii Lani (comprised of the former Alii Lani Phase 1A, Alii Lani Phase 1B, Alii Lani Phase 1C, Alii Lani Phase 1D and Alii Lani Phase 1E projects, which were merged for ownership purposes), developed by the Developer on land adjacent to the Project land) with the Project. In the Developer's discretion, any such merger shall be for administrative purposes only (an "administrative merger") or for both administrative purposes and for purposes of allocating ownership of common elements in the projects to be merged among all of the apartment owners of the merged project. In the event of merger for purposes of allocating ownership interest (an "ownership merger"), each apartment owner's common interest appurtenant to his or her apartment will be recalculated and may be reduced or increased to reflect that proportion which his or her apartment's net interior floor area bears to the total net interior floor area of all apartments in the merged project. The Developer has the right to execute and record amendments to the Declaration and other documents to effect such a merger, including but not limited to a consolidation of the land covered by the Project with any other parcel(s) of land in connection with a merger, in accordance with the terms and provisions of the Declaration of Merger of Condominium Phases, a copy of which is on file with the Real Estate Commission.

See Section Q of the Declaration for easements reserved to the Developer with respect to the construction, maintenance, operation and sale of the phases. See also page 16 of this public report for further information concerning merger.


#### F. RESERVATION TO DEVELOP INCREMENTALLY

The Developer has reserved the right, but is not obligated, to construct, sell and convey the apartments in the Project incrementally on a building-by-building or cluster-by-cluster basis. Upon the completion of each building or cluster, the Developer may transfer ownership of the apartments to apartment purchasers. In connection with this incremental development, the Developer has the right to enter upon the Project premises with employees, agents and contractors for all purposes reasonably necessary for or useful to constructing and completing all increments to the Project. See Section Q1 of the Declaration for details regarding the Developer's right to develop the Project in increments.

G. RESERVATION TO DELETE APARTMENTS

The Developer has reserved the right to delete from the Project any of the buildings of the Project along with the apartments to be contained therein, together with those common elements that would support and service such deleted building(s) and the apartments therein (the "deleted apartments"). Upon any such deletion of the deleted apartments, the Developer may: (i) amend the Declaration to (a) revise the description of the Project to delete reference to the deleted apartments, and (b) revise the percentage common interest of each apartment in the amended project; and (ii) amend the Condominium Map to show any changes in the Project. The Developer's ability to delete the deleted apartments shall expire upon the first conveyance of any of the deleted apartments to any person or entity other than the Developer. See Section P1 of the Declaration for more details regarding the Developer's right to delete apartments from the Project.


