The issuance by the Commission of an effective date for this Developer's Public Report (1) does not mean that the Commission approves or disapproves of the project; (2) does not mean that the Commission thinks that either all material facts or all pertinent changes, or both, about the project have been fully or adequately disclosed; and (3) is not the Commission's judgment of the value or merits of the project.

This report may be used by the Developer for promotional purposes only if it is used in its entirety. No person shall advertise or represent that the Commission has approved or recommended the project, this report or any of the documents submitted with Developer's application for registration of this project.

This report will be amended if, after the effective date of this report, any changes, either material or pertinent changes, or both, occur regarding the information contained in or omitted from this report. In that case, the Developer is required to submit immediately to the Commission an amendment to this report or an amended Developer's Public Report, clearly reflecting the changes, including any omitted material facts, together with such supporting information as may be required by the Commission. Annually, at least thirty days prior to the anniversary date of the Effective Date of this report, the Developer shall file an annual report to update the material contained in this report. If there are no changes, the Developer is required to state that there are no changes. The Developer's obligation to amend this report or to file annual reports ends when the initial sales of all units in the project have been completed.

Purchasers are encouraged to read this report carefully and to seek professional advice before signing a sales contract for the purchase of a unit in the project.

Signing a sales contract may legally bind a purchaser to purchase a unit in the project, though a purchaser may have rights to cancel or rescind a sales contract under particular circumstances that may arise.

General Information On Condominiums

A condominium is a special form of ownership of real property. To create a condominium in Hawaii after July 1, 2006, the Condominium Property Act, Chapter 514B, Hawaii Revised Statutes, must be followed. In addition, certain requirements and approvals of the county in which the project is located must be satisfied and obtained.

Some condominium projects are leasehold. This means that the land and/or the building(s) and other improvements are leased to the purchaser. The lease for the land usually requires that at the end of the lease term, the lessees (unit owners) deliver their interest in the land to the lessor (fee property owner).

If you are a typical condominium unit owner, you will have two kinds of ownership: (1) ownership in your individual unit; and (2) a percentage interest in the common elements.

You will be entitled to exclusive ownership and possession of your unit. Subject to the documents governing them, condominium units may be individually bought, sold, rented, mortgaged or encumbered, and may be disposed of by will, gift or operation of law.

Your unit will, however, be part of the group of units that comprise the condominium project. Study the project's Declaration of Condominium Property Regime, Bylaws of the Association of Unit Owners, Condominium Map and House Rules, if any, which are being concurrently delivered to you with this report. These documents contain important information on the use and occupancy of the units and the common elements of the project, as well as the rules and regulations of conduct for unit owners, tenants and guests.

Operation of the Condominium Project

The Association of Unit Owners is the entity through which unit owners may take action with regard to the administration, management and operation of the condominium project. Each unit owner is automatically a member of the Association.

The Board of Directors is the governing body of the Association. Unless you serve as a board member or an officer, or are on a committee appointed by the board, your participation in the administration and operation of the condominium project will in most cases be limited to your right to vote as a unit owner. The Board and officers can take certain actions without the vote of the unit owners. For example, the Board may hire and fire employees, increase or decrease maintenance fees, adopt budgets for revenues, expenses and reserves and regulate the use, maintenance, repair and replacement of common elements. Some of these actions may significantly impact the unit owners.

Until there is a sufficient number of purchasers of units to elect a majority of the Board, it is likely at first that the Developer will effectively control the affairs of the Association. It is frequently necessary for the Developer to do so during the early stages of development and the Developer may reserve certain special rights to do so in the Declaration and Bylaws. Prospective purchasers should understand that it is important to all unit owners that the transition of control from the Developer to the unit owners be accomplished in an orderly manner and in a spirit of cooperation.

5.8 Purchaser's Right to Cancel or Rescind a Sales Contract

A purchaser's right to cancel a sales contract or to rescind a sales contract may arise under varying circumstances. In the sections below, some circumstances that will give rise to a purchaser's right to cancel or rescind are described, together with what a purchaser must do if the purchaser wishes to exercise any of the rights.

5.8.1 When a Sales Contract becomes Binding and Purchaser's 30-Day Right to Cancel a Sales Contract

A sales contract signed by a purchaser and the developer will not become binding on a purchaser or the Developer until the following events have taken place:

(1) The purchaser has signed the sales contract.
(2) The Developer has delivered to the purchaser a true copy of the developer's public report with an effective date issued by the Commission, together with all amendments to the report as of the date of delivery, and the project's recorded Declaration and Bylaws, House Rules (if any), the Condominium Map and any amendments to them to date (all of which are a part of the developer's public report). If it is impracticable to include a letter-sized Condominium Map, the Developer must provide written notice of an opportunity to examine the Condominium Map.

(3) The Developer has delivered to the purchaser a notice of the purchaser's 30-day cancellation right on a form prescribed by the Commission.

(4) The purchaser does at least one of the following:

(a) Waives the purchaser's right to cancel the sales contract within 30 days from receipt of the notice of the purchaser's 30-day cancellation right; or

- (b) Allows the 30-day cancellation period to expire without exercising the right to cancel; or
- (c) Closes the purchase of the unit before the 30-day cancellation period expires.

The purchaser or the Developer may cancel the sales contract at any time during the 30-day cancellation period, and the sales contract will be canceled and the purchaser's deposits returned to the purchaser, less any escrow cancellation fee and other costs associated with the purchase, up to a maximum of \$250.

5.8.2 Right to Cancel a Sales Contract if Completion Deadline Is Missed

In addition to the purchaser's 30-day cancellation right described in Section 5.8.1 above, when a sales contract is signed before completion of construction of a project, the purchaser will have the right to cancel if the unit is not completed by certain deadlines. In conversion projects, there must be a deadline for completion of any required repairs. Every sales contract shall contain an agreement of the Developer that the completion of construction shall occur on or before the completion deadline, and that completion deadline is set forth in this report in Section 5.5. The sales contract shall provide that the purchaser may cancel the sales contract at any time after the specified completion deadline, if completion of construction does not occur on or before the completion deadline, as the same may have been extended. Upon a cancellation, the purchaser's deposits shall be refunded, less any escrow cancellation fee and other costs associated with the purchase, up to a maximum of \$250.00.

5.8.3 Purchaser's Right to Rescind a Binding Sales Contract After a Material Change

If a "material change" in a project occurs after a purchaser has signed a sales contract that has become binding, the purchaser will have a 30-day right to rescind after notification and description of the material change. A material change is defined in the Condominium Property Act to be any change that "directly, substantially and adversely affects the use or value of (1) a purchaser's unit or appurtenant limited common elements; or (2) those amenities of the project available for the purchaser's use."

The purchaser will be informed of the material change by the developer on a form prescribed by the Commission containing a description of the material change.

After notice of the material change, the purchaser may waive the right to rescind by:

- (1) Checking the waiver box on the rescission form; or
- (2) Letting the 30-day rescission period expire, without taking any action to rescind; or
- (3) Closing the purchase of the unit before the 30-day rescission period expires.

The rescission form must be signed by all purchasers of the affected unit and delivered to the developer no later than midnight of the 30th calendar day after the purchasers received the rescission form from the developer. Purchasers who validly exercise the right of rescission shall be entitled to a prompt and full refund of any moneys paid.

A rescission right shall not apply in the event of any additions, deletions, modifications and reservations including, without limitation, the merger or addition or phasing of a project, made pursuant to the terms of the project's Declaration.

These provisions shall not preclude a purchaser from exercising any rescission rights pursuant to a contract for the sale of a unit or any applicable common law remedies.

6. MISCELLANEOUS INFORMATION NOT COVERED ELSEWHERE IN THIS REPORT

The Developer has used the term “dwelling” in the Declaration and the By-laws of the Project. This term has the same meaning of “unit” as used in the Condominium Property Act, Chapter 514B, Hawaii Revised Statutes.

The terms “apartment”, “dwelling” and “unit” are used interchangeably throughout this report and some documents.

Section 5.2, page 13 of the Developer’s Public Report:

This condominium project is subject to the sale to owner-occupants requirements, whereby at least 50% of the units have to be offered for sale to owner-occupants. As only one (1) unit is being offered for sale under this Developer’s public Report, the developer will NOT be designating the unit for sale to an owner-occupant. Future offerings of units for sale will require that at least three (3) units will be subject to the sale to owner-occupants requirements.

No Joint Venture or Responsibility:

1. Each Unit with the Project is owned by a different owner as described on Page 1. Any representation or obligation with respect to a Unit contained herein or in any of the documentation in connection with the sale of a Unit is intended only to be made by or the obligation to be incurred by the Owner of such Unit. Owners shall have no liability or obligation with respect to a Unit not owned by such Owner. The Owner shall have no joint liability with respect to the construction or development of a Unit or the Project.
2. The Owners of Unit 1725-B and the Owners of the other five units are joining in this Developers Public Report as required by the Commission.
3. An Owner of one Unit is not a partner or joint venture of the Owners of the other Units. Each Unit Owner shall not be held responsible to the Association for the project, any current or future Unit Owner or any other person for any design or construction defects in any portion of the Project (including the common elements or any Unit) or for any other claims or liabilities arising therefrom or for any redesign, reconstruction or repair hereafter to any portion of the Project.

The Developer declares subject to the penalties set forth in Section 514B-69, HRS, that this project conforms to the existing underlying county zoning for the project, zoning and building ordinances and codes and all applicable permitting requirements adopted by the county in which the project is located, all in accordance with Sections 514B-5 and 32(a)(13), HRS.

EXHIBIT "A"

PERMITTED ALTERATIONS TO THE DWELLINGS

Paragraph M of the Declaration provides:

Restoration or replacement of any dwellings or construction of any additional improvements, alterations or additions to any dwellings different in any material respect from the Condominium Map of the Project shall be undertaken by a dwelling owner, subject to the conditions set forth below:

1. All plans and specifications therefore shall comply with applicable setback requirements, building codes and zoning ordinances.

2. No dwelling shall be changed so as to reduce the distance between improvements placed on each land area to less than the distance shown on the Condominium Map without the consent of the other owner, and no change to a dwelling shall be made if the effect of such change would be to exceed the dwelling's proportionate share of the allowable floor area or lot area coverage for the land on which the Project is located, pursuant to the then applicable zoning and building codes. The proportionate share for each dwelling shall be the same as its percentage interest in the common elements.

3. All changes shall be at the sole expense of the dwelling owner making such changes and shall be completed expeditiously and in a manner that will not unreasonably interfere with the owners' use of their dwellings or land areas.

4. During construction, the dwelling owner making such changes will obtain at its sole expense builder's all-risk insurance in an amount not less than the estimated cost of construction, and the Association shall be named as additional insured.

5. Promptly upon completion of such restoration, replacement or construction, the owner shall duly record or file of record an amendment to the Declaration, together with a complete set of floor plans of the dwelling as so altered, certified as built by a registered architect or professional engineer; provided, however, that notwithstanding any provision in this Declaration to the contrary, any alterations or additions within a dwelling may be undertaken without an amendment to this Declaration or filing of a complete set of floor plans of the dwelling so altered. All present and future dwelling owners and their mortgages, by accepting an interest in the Project, shall be deemed to have given each dwelling owner a power of attorney to execute such an amendment to this Declaration, so that each dwelling

owner shall have a power of attorney from all other dwelling owners to execute such an amendment. This power of attorney shall be deemed coupled with each owner's interest in such owner's dwelling and shall be irrevocable.

6. Each conveyance, lease and mortgage or other lien made or created on any dwelling in the Project and all common interests and other appurtenances thereto shall be subject to the provisions of this paragraph M.

Declarant does not give any assurances that the dwellings can be expanded, and Declarant does not give any assurances that variances are obtainable from the City and County of Honolulu for any proposed improvements.

EXHIBIT "B"

DESCRIPTION OF COMMON ELEMENTS

The "common elements" shall include, but not be limited to, the following:

- (a) Said land in fee simple;
- (b) All foundations, floor slabs, columns, beams, supports, walls, roofs, stairways, walkways within the Project which serve more than one unit;


SPECIAL USE RESTRICTIONS

Paragraph E of the Declaration provides:

The units shall be occupied and used only as private single-family unit by the respective owners, their families, domestic servants, social guests, and tenants and for no other purposes. The units or any interest therein shall not be sold, transferred, conveyed, leased, occupied, rented or used for or in connection with any time-sharing purpose or under any time-sharing plan, arrangement or program, including without limitation any so-called "vacation license", "travel club membership" or time-interval ownership" arrangement. The term "time-sharing" as used herein shall be deemed to include, but is not limited to, any plan, program or arrangement under which the right to use, occupy, own or possess a unit or units in the Project rotates among various persons on a periodically recurring basis according to a fixed or floating interval or period of time, whether by way of deed, lease, association or club membership, license, rental or use agreement, co-tenancy agreement, partnership or otherwise. The units shall not be rented for transient or hotel purposes, which are defined as (i) rental for any period less than thirty (30) days, or (ii) any rental in which the occupants of the unit are provided customary hotel services such as room service for food and beverage, maid service, laundry and linen or bellboy service. Except for such transient or hotel purposes the owners of the respective units shall have the absolute right to lease such units subject to all provisions of this Declaration.

This is in response to your letter dated September 21, 2010, requesting verification that the structures on the above-mentioned property met all applicable code requirements at the time of construction.

Investigation revealed that the two one-story single-family detached dwellings at 1730 Maliu Street and 1725C Perry Street, relocated and posted prior to 1959; the two-story single-family detached dwelling at 1725F Perry Street, built in 2008; and the two-story single-family detached dwelling at 1725B Perry Street, built in 2009, met all applicable code requirements when they were built/relocated on this 38,724-square-foot R-5 Residential-District-zoned lot.

On August 27, 2001, Existing Use Permit No. 2001/EU-8 was approved with conditions for six single-family detached dwellings.

On July 27, 2007, Variance File No. 2007/VAR-30 was approved with conditions to allow the reconstruction of two one-family detached dwellings, which were not reconstructed within the 2-year time limit.

For your information, the Department of Planning and Permitting cannot determine all legal nonconforming uses or structures as a result of the adoption or amendment of any ordinance or code.

No other variances or special permits were granted to allow deviations from any applicable codes.

EXHIBIT "G"

DEVELOPER'S RESERVED RIGHTS

Paragraph Q of the Declaration provides:

Developer reserves the right for itself and its agents to do the following until such time as all of the dwellings in the Project are sold, without the consent, joinder or approval of the Association or any dwelling purchaser or owner of any mortgagee.

1. To grant to any public utility or governmental authority easements for sewer, drainage, water and other utility facilities over, under, along, across and through the land on which the Project is located, all under the usual terms and conditions required by the grantee for such easement rights; to grant to any other person or entity any easements for ingress, egress or roadway purposes over, under, along, across and through said land (provided, however, that such easement rights shall be granted and exercised in such a manner as not to unreasonably damage the dwellings or unreasonably interfere with the use of said land by the dwelling owners and their successors and assigns); and to quitclaim any easements in favor of the Project which are not required for the Project. Each dwelling owner and any person claiming an interest in said land by, through or under such dwelling owner, shall, upon request, join in and execute any and all documents designating, granting and quitclaiming any such easements.

2. To amend this Declaration, the Condominium Map and the By-Laws consistent with any grants or reservations of rights by Developer under the Declaration.

3. To conduct sales of dwellings on and at the Project, including, but not limited to, maintaining model dwellings, operating a sales office, conducting advertising, placing signs, using parking spaces and erecting lighting in connection with such sales; provided, however, that Developer shall not use any dwelling (or its limited common elements) with respect to which an apartment deed has been recorded (other than

in the name of Developer as grantee); provided, further, that in exercising such right, Developer shall not interfere with the rights of any dwelling owner to the use of, or access to, his dwelling or any of the common elements or limited common elements appurtenant thereto.

4. To amend the Declaration, the By-Laws and the Condominium Map, as may be required by law, by the Real Estate Commission of the State of Hawaii, by any title insurance company issuing a title insurance policy on the Project or any of the dwellings, by any institutional lender lending funds on the security of the Project or any of the dwellings, by any purchaser, insurer or guarantor of loans, including, for example, the Federal National Mortgage Association or Federal Home Loan Mortgage Corporation, to enable it to purchase, insure or guarantee a loan made on the security of the Project or any of the dwellings, or by any governmental agency; provided, however, that no such amendment which would change the common interest appurtenant to any dwelling or substantially change the design, location or size of a dwelling in the Project shall be made without the consent to such amendment by all persons having an interest in such dwelling.

5. To reconfigure the Project or any dwelling with respect to which a deed has not been recorded.

3. Developer discloses that no reserve study was done in accordance with Section 514B HRS, and the replacement reserve rules, Subchapter 6, Title 16, Chapter 107, Hawaii Administrative Rules, as amended. The individual unit owners will be solely responsible for the maintenance and repair of their own units and its appurtenant Privacy areas.
4. All the owners will share the cost of maintenance and repair of any common element which serves more than one unit, in the same portion as to the common interest in the Project, when such maintenance and repair becomes necessary.

EXHIBIT "I"

SUMMARY OF SALES CONTRACT

1. The sales agreement contains the price and other terms and conditions under which a buyer will agree to buy an unit in the Project.
2. The contract provides for the buyer to get a copy of certain legal documents that buyer should closely examine.
3. The contract provides remedies to seller if buyer fails to comply with the terms and conditions of the contract.
4. The buyer must complete the sale and purchase of the unit by a certain date and pay closing costs, in addition to the purchase price.
5. The buyer's money will be held in escrow under the terms of the escrow agreement for the Project.
6. The developer is making no warranties or representations in connection with the sale of any of the units.
7. The sales contract is not assignable without the written consent of seller.

This is merely a highlighted summary of certain of the terms and conditions of the sales contract, and any buyer should review all the terms and conditions of the sales agreement before signing.

EXHIBIT "J"

SUMMARY OF ESCROW AGREEMENT

The Escrow Agreement sets up an arrangement under which an independent neutral party ("Escrow") will perform all the necessary steps to close the transaction. The following is the summary of the Escrow Agreement:

- (A) Funds from Purchaser: All payments made by purchaser pursuant to the sale contract shall be deposited to Escrow.
- (B) Interest on Funds in Escrow: Any interest earned on funds deposited in Escrow shall accrue as specified in the sales contract, unless otherwise stated.
- (C) Escrow will arrange for purchasers to sign all necessary documents.
- (D) The Escrow Agreement says under the following conditions a refund will be made to a purchaser:
 - (1) Seller and purchaser have requested Escrow in writing to refund to purchaser.
 - (2) Purchaser exercises his rescission right.
 - (3) Purchaser exercises his cancellation right under the sales contract.

Upon cancellation of Escrow, Escrow is entitled to a fee as specified in the Escrow Agreement.

- (E) When seller certifies in writing to Escrow that seller has terminated the sales contract upon purchaser's default under the Sales Contract and purchaser fails to cure the default, escrow will treat all funds paid by purchaser as funds of seller unless Escrow's cancellation fees.
- (d) Purchaser's fund will be release to seller upon certain applicable conditions as stated in paragraph 5. Purchaser is encouraged to refer to such paragraph of the Escrow Agreement.

The Escrow Agreement contains many other provisions and establishes certain charges that may be incurred by the purchaser, and the purchaser should carefully read the entire Escrow Agreement.




1. All work shall be in accordance with approved application documents, the conditions enumerated below and the Land Use Ordinance (LUO) unless otherwise stated by this permit.
- ✓ 2. One of the existing dwellings on proposed CPR Unit 6 shall be relocated and/or constructed on proposed CPR Unit 2 to replace the previously demolished dwelling. No building permit to construct a dwelling on CPR Unit 6 shall be approved until:
 - ✓ a) a demolition permit is issued for one of the two dwellings (Unit 1725F or Unit 1725E) on proposed CPR Lot 6; and
 - ✓ b) an after-the-fact demolition permit is issued for the demolished dwelling on proposed CPR Lot 2.
3. The EU permit is only for the continued use, repair, alteration, expansion, relocation, or reconstruction of one existing dwelling on each of the remaining proposed CPR lots. This Existing Use approval does not certify that those existing structures and improvements comply with the current zoning code or other regulations.
4. In accordance with Section 2.100(a) of the LUO, in the event of destruction, uses may be continued and structures may be rebuilt under the approved existing use plan, provided that such restoration is permitted by the Building Code and Flood Hazard Regulations and is started within two years.

EXHIBIT "M"

5. Only minor modifications to the EU plans shall be allowed. Any major modification which may have an adverse impact on surrounding land uses, increases the number of dwelling units and/or involves the reconstruction and/or expansion of a dwelling(s) which is part of a larger development, shall require the processing of a Cluster Housing Permit.
6. The applicant or owner(s) shall incorporate this Existing Use Permit into the restrictive covenants which run with the land, to serve as notice to all owners and tenants. The draft covenant shall be submitted for review and approval by the DPP. Upon approval of the covenant, a certified recorded copy shall be filed with the DPP, prior to the change in any ownership or the issuance of any permits.
7. The applicant or owner(s) shall submit a copy of the approved Condominium Property Regime (CPR) map and documents to the DPP. Future work subsequent to the creation of a CPR may require approval from the homeowners association prior to the start of work. If the EU Permit is incorporated into the CPR documents, a separate declaration of restrictive covenants is not required.
8. All work shall comply with the applicable Land Use Ordinance (LUO) standard for the underlying zoning district, unless otherwise stated herein:
 - a. All structures shall comply with required yard and height setbacks of the underlying zoning district as measured from perimeter property lines and the proposed limited common element (CPR) lines.
 - b. Minimum 5-foot setback for fences, walls and structures shall be required from the common access drive and common element lines.
 - c. Maximum building area shall not exceed 40 percent of each unit's private yard area (limited common element).
9. All new work shall be compatible in design with the existing and surrounding structures. The Director may require the redesign of exterior entrances, stairways, bar areas, including plumbing and electrical systems, to ensure that the number of dwellings is not increased.
10. The common access driveway, individual driveways and a minimum of two (2) stalls for each dwelling unit shall be provided with an all-weather surface, prior to the issuance of any building permits for that respective dwelling unit. Dwelling additions shall comply with the LUO parking regulations. Existing parking spaces within carports or garages shall not be converted into usable floor area (including garage or carport storage areas).
11. All existing trees 6 inches or greater in diameter shall be retained on-site, or replacement landscaping shall be required. All landscaping shall be maintained in a healthy visual condition at all times.
12. Any modification to the application documents and conditions stated herein shall be subject to approval by the DPP. For good cause, the Director may impose additional requirements and/or amend the above conditions.

Six (6) freehold estates are hereby designated in the Project. Two units are located in two two-story buildings without basement. Four units are located in four one-story buildings without basement. The buildings are constructed principally of concrete, wood, and glass. Said freehold estates are referred to herein as "unit" and are designated on the Condominium Map and are located in the building and contain the number of rooms and the number of floors as set forth as follows:

1. Unit types:

Unit 1725 is a one story unit with a total net living area of approximately 620 square feet. It consists of three bedrooms and one bathroom, a living room and a kitchen. It also includes two open parking stalls and a covered patio of 104 square feet.

Unit 1725-B is a two story unit with a total net living area of approximately 1891 square feet. The first floor consists of a family room, two bedrooms and one bathroom, which contains approximately 739 square feet of net living area. The second floor contains a net living area of approximately 1152 square feet, and includes 3 bedrooms (including master bedroom), 2 bathrooms (including master bath), a living room, a dining room and a kitchen. The floors are connected by an interior stairway. It also includes a two-car garage with an area of 413 square feet.

Unit 1725-C is a one story unit with a total net living area of approximately 606 square feet. It consists of three bedrooms and one bathroom, a living room and a kitchen. It also includes a two-car carport with an area of 378 square feet.

Unit 1725-D is a one story unit with a total net living area of approximately 700 square feet. It consists of two bedrooms, one storage room and one bathroom, a living room and a kitchen. It also includes a 256 square feet two-car carport.

Unit 1725-F is a two story unit with a total net living area of approximately 1891 square feet. The first floor consists of a family room, two bedrooms and one bathroom, which contains approximately 739 square feet of net living area. The second floor contains a net living area of approximately 1152 square feet, and includes 3 bedrooms (including master bedroom), 2 bathrooms (including master bath), a living room, a dining room and a kitchen. The floors are connected by an interior stairway. It also includes a two-car garage with an area of 413 square feet.

Unit 1730 is a one story unit with a total net living area of approximately 924 square feet. It consists of three bedrooms and one bathroom, a living room, a family room, a dining room and a kitchen. It also includes two open parking stalls and a covered patio with 144 square feet.

The net living areas set forth hereinabove were computed by measuring from the interior surface of the unit perimeter walls; no reduction has been made to account for interior walls, ducts, shafts and the like located within the perimeter walls. The approximate net living areas set forth above do not include the garage, parking stall and any areas not fully enclosed.
