PREFACE:

- ON MONDAY, JULY 21, 2008, 6 Y.O. RONELA PASCUAL WAS TAKEN TO THE QUEEN'S MEDICAL CENTER (QMC) BY AMBULANCE FROM HER HOME AFTER SHE REPORTEDLY FELL FROM A STAIRWAY ONTO A WOODEN FLOOR. SHE SUSTAINED SERIOUS HEAD INJURIES AS A RESULT OF THE FALL.
- SHE IS IN CRITICAL CONDITION AND WILL REMAIN HOSPITALIZED AT QMC. SHE HAS ALREADY BEEN IN SURGERY TO RELIEVE SWELLING ON THE BRAIN.

HARM:

- LACK OF SUPERVISION, THREAT OF HARM (RULE OUT ABUSE) BASED ON THE FOLLOWING:
  -

MOTHER'S EXPLANATION OF THE INCIDENT:

- ON MONDAY, JULY 21, 2008, 6 Y.O. RONELA PASCUAL WAS TRANSPORTED TO QMC VIA AMBULANCE AFTER SHE REPORTEDLY SUSTAINED HEAD INJURY FROM A FALL IN HER HOME. THE INCIDENT REPORTEDLY OCCURRED AROUND NOON.
- MOTHER REPORTED THAT SHE WAS IN ANOTHER ROOM, HEARD A THUD, AND WENT TO WHERE RONELA LAY ON THE FLOOR UNCONSCIOUS.

- RONELA REPORTEDLY HAD FALLEN OFF A STAIRWELL, SOME 6-7 STEPS ABOVE A WOODEN FLOOR.
- RONELA REPORTEDLY FELL ONTO THE WOODEN FLOOR FROM A HEIGHT OF SEVERAL FEET, HER HEAD STRIKING THE WOODEN FLOOR.
- MOTHER REPORTEDLY LAY HER ON A SOFA. WHEN RONELA DID NOT REGAIN CONSCIOUSNESS, MOTHER REPORTEDLY CALLED AN AMBULANCE.
- THE AMBULANCE ARRIVED AT THE HOME SOMETIME AFTER NOON; THE CHILD ARRIVED IN THE QMC EMERGENCY ROOM AT APPROXIMATELY 1300 HOURS.

INJURIES:

- QMC DOCTORS PERFORMED SURGERY TO RELIEVE SWELLING IN THE CHILD'S BRAIN. THE CHILD SUFFERED A "BRAIN SHIFT," CAUSING EXTENSIVE BLEEDING ON THE BRAIN AND SWELLING.
- AT TIME OF INTAKE, 1700 HOURS, THE CHILD'S CONDITION WAS CRITICAL, LIFE THREATENING.
- RONELA WILL REMAIN IN THE PEDIATRIC INTENSIVE CARE UNIT AT QMC.

OTHER INFORMATION:

- MOTHER REPORTEDLY WAS "HYSTERICAL" WHEN THE EMERGENCY MEDICAL TECHNICIANS ARRIVED AT THE HOME.
- MOTHER TOLD THE AMBULANCE STAFF THAT SHE COULD NOT LEAVE THE HOME, COULD NOT LEAVE HER OTHER TWO CHILDREN.

- AFTER THE CHILD, RONELA, ARRIVED AT QMC, THE QMC STAFF CALLED MOTHER TO HAVE HER COME TO THE HOSPITAL. MOTHER SAID SHE COULD NOT COME TO QMC AT THAT TIME, THAT SHE HAD TO CARE FOR HER OTHER 2 CHILDREN.
- QMC CALLED FATHER AT HIS WORK PLACE. FATHER SAID HE WAS WORKING AND COULD NOT GET TO THE HOSPITAL.
- NEITHER PARENT APPEARED TO GRASP THE GRAVITY OF THE SITUATION, PER QMC SOCIAL WORKER
- BOTH PARENTS HAD ARRIVED AT QMC BY THE TIME OF THE CHILD WELFARE INTAKE (CWI) REPORT AT 1700 HOURS.
- THE QMC STAFF FOUND THE PARENTS TO BE "VERY CONCRETE" WITH WHAT APPEARED TO BE COGNITIVE DEFICIENCIES. THE PARENTS APPEARED TO HAVE LITTLE ABILITY TO PROBLEM SOLVE.

- CWI CALLED HPD/CID LT. STRUSS TO INFORM THEM OF SERIOUS INJURY.
- LT. STRUSS WILL SEND AN HPD DETECTIVE TO QMC.
- HPD DET. AH SING CALLED CWI FOR INFORMATION AND WAS ON HIS WAY TO QMC TO INTERVIEW THE PARENTS AND DOCTORS BY 1730 HOURS.
- HPD REPORT # NOT AVAILABLE.
