LYNETTE MIKI, SOCIAL WORKER AT KAPIOLANI MEDICAL CENTER, UPDATE THE CURRENT STATUS OF RONELA PASCUAL. RONELA WILL UNDERGO A TRACHEOSTOMY PROCEDURE SOME TIME NEXT WEEK. THE PROCEDURE IS TO HELP HER BREATH TO PRESERVE THE AIRWAY TO HAULT FURTHER BRAIN DAMAGE. THE PROCEDURE WILL ALSO BE DONE TO SEE IF SHE CAN BREATH ON HER OWN WITHOUT THE ASSISTANCE OF A VENTILATOR. THE VENTILATOR IS CURRENTLY SET AT A STEADY RATE. SWELLING OF THE BRAIN HAS REDUCED. SHE HAS SOME PRIMAL LEVEL FEELING IN HER EXTREMETIES. THE NEUROLOGIST ATTENDING TO RONELA REPORTS THAT IT IS HIGHLY UNLIKELY THAT COGNITIVE ABILITY WILL IMPROVE TO A NORMAL STATE. HER EYES FOR EXAMPLE IS NOT EXPECTED TO OPEN. RECOVERY FOR HIGHER THINKING IS NOT EXPECTED. DEATH IS NOT IMMINENT. MS. MIKI STATED THAT IT IS HIGHLY LIKELY THAT RONELA WILL REQUIRE 24 HOUR CARE FOR THE REST OF HER LIFE. DISCHARGE FROM THE HOSPITAL DEPENDS ON HER RECOVERY. IF SHE CAN BREATH ON HER OWN, DISCHARGE MAY HAPPEN AFTER HER CARETAKER IS TRAINED IN CARING FOR HER NEEDS.
