HIS OWN FA/PAT.GRDMO WAS DECEASED WHEN HE WAS AGE 12 IN 1982, MED.CAUSE HE STATES 'LEUKEMIA' HIS OWN FA/PAT.GRDFM WAS DECEASED WHEN HE WAS AGE 5; CAUSE OF HIS DEATH, 'SMASHED BY A BULL',WORKING AS A RANCHER. KEMA SR SAID THAT HIS DAD WAS 'PARALYZED,DIED AT HOME.' THAT WAS IN 1975, WHEN HIS DAD WAS IN HIS 50'S'...

NUCLEAR FAMILY RELATIONSHIP: WHEN HE WAS FIVE YRS OLD, LIVING W HIS MO & FA,

THE OLDEST SIBLING WAS JOSEPH, 'IN NEXT ROOM, EVERYBODY TOOK CARE OF HIM, HE ACKNOWLEDGED THAT HE WAS MENTALLY RETARDED (DEVELOPMENTALLY DISABLED) & COULD NOT PROVIDE FOR HIS OWN PHYSICAL NEEDS. (HPD DET RELAYED THAT IN THE COMMUNITY, IT WAS KNOWN THAT OLDER SIB,JOSEPH, WAS KEPT IN ANOTHER BLDG, ALSO CALLED A SHED; THE DESCRIPTION RENDERED AN IMPRESSION THAT THIS OLDER SIBLING WAS NOT GIVEN HUMANE CARE.

PAT.GRDFM/HIS DAD, THOMAS N. KEMA, DIED WHEN PETER SR WAS AGE FIVE YRS. "SMASHED BY A BULL" WHILE WORKING AS A RANCHER. HE WAS THEN PARALYZED AND DIED AT HOME. THIS WAS IN 1975, WHEN PETER SR. WAS AGE 5.

JOSEPH HAD EPILEPSY AFTER 'FALLNG BACKWARDS AT A SCHOOL OFF THE RAILING'.

AFTER HIS OWN MOTHER'S DEATH WHEN HE WAS AGE 13, HE WENT TO LIVE WITH HIS HALF-SISTER, RACHEL KEMA, WHO IS ABOUT 20 YRS SENIOR TO HIM.

JUST PRIOR TO MOTHER'S DEATH, HIS MOTHER HAD HER 'BOYFRIEND', MOSES MAKUAKANI, LIVING WITH THEM FOR FIVE YEARS PRIOR TO HER DEATH. THEY LIVED AT 73123 LOLOA DRIVE, 'FIRST HOUSE ON THE RIGHT'....THAT WAS IN 1982. AFTER HIS MO DIED, HIS OLDER SISTER, LEE ANN AGE 14 AND BROTHER, THOMAS AGE 13, "LEFT HOME,STAYED WITH NEIGHBORS OR AT FRIEND'S HOUSE....UNCLE MOSES WAS WORKING 'SECURITY JOBS' HE WORKED A 'KEAHO' GOLD COURSE, IN EARLY 1980'S (1981, 1983). THEN MOSES LEFT PETER SR. TO LIVE WITH HIS OWN SISTER..."MOSES DID NOT WANT THE RESPONSIBILITY (OF CARING FOR PETER SR.) PETER SR. SAYS HE ATTENDED 'KEALAKEKUA ELE/INTERMED. SCHOOL (KONA?) "I WAS EXPELLED FROM SCHOOL BECAUSE I FLEW A CHAIR AT A BOY AFTER HE FLICKED A STAPLE IN MY EYES.'.....PETER SR.ADDED, 'I ACCIDENTLY HIT A TEACHER WITH MY ARM, BACKWARDS.'...HE WAS 12 YRS OLD, HE SAID. I WENT TO MT.VIEW SCHOOL WITH MY OLDER SISTER, RACHEL, WHO WAS 20 YRS

"ROSE WENT TO OAHU; I DON'T KNOW WHERE SHE WENT. THE NEXT TIME I SAW HER WAS IN SEPT, 1997..."

MARRIAGE RELATIONSHIP & MEETING 'ROSE'."ME & WIFE SEPARATED AUGUST, 1997. I LIVED IN AALA PARK ON THE GRASS AREA FOR THIRTY DAYS. (AND) IN A TENT WHERE 18 PEOPLE STAYED, (WITH PETER JR.,HE SAID.) I MET AUNTIE IN MID-SEPT/97. SHE WAS SELLING 'LAHOLA HATS'. SHE'S ABOUT 42 OR 43 YRS OLD. SHE WAS SELLING HATS AT FIVE DOLARS EACH; IT TAKES A DAY TO MAKE ONE. I DDINT ASKED HER HOW LONG IT WOULD TAKE TO MAE THEM. IT WAS A HOT DAY, IN MIDDLE OF DAY. SHE WORE SHORTS, SHOES, SHIRT. HER HAIR WAS IN PONY TAIL,BLACK WITH WHITE HAIR, LONG, SHOULDER-LENGTH. SHE'S 100% HAWAIIAN. (HERITAGE).

NARRATIVE ACCOUNT

KEMA SR SAID THAT HE TALKED W HER. "I WISHED SHE HAD WENT.....(WHEN HE WAS AGE TWELVE)..HE SPOKE OF HIS SENSE OF LOSS IMMEDIATELY AFTER HIS MOTHER DIED. "AFTER ONE WEEK, I GAVE PETER JR. TO HER." KEMA SR WAS ASKED WHAT HE HAD GIVEN THIS WOMAN HE CALLS ROSE, IN EXCHANGE FOR PETER JR. HE DID NOT ANSWER; HE WRINKLED UP HIS FACE IN AN EMOTIONAL RESPONSE. HE SAID HE HAD NO FOOD STAMPS; "MONEY. RUNNING OUT. I TOLD MYSELF 'I CAN'T FEED HIM GOOD. THIS IS NO PLACE FOR A CHILD.'" HE SAID HE WROTE A NOTE TO ROSE. "I MADE A COPY AT 7-11 (STORE). I HAVE THE ORIGINAL. (HE SAID THAT HE ALSO GAVE A COPY TO DET.NOJIRI,HPD, HILO.)

KEMA SR SAID THAT HE "SAW ROSE EVERY DAY FOR FIVE DAYS. I WANTED TO SEE IF MY SON WOULD GO TO BE WITH HER. AT FIRST, SHE SHE SAID SHE'D GO TO THE MAINLAND, AND THEN GO TO FLORIDA. IN FLORIDA....I NEVER ASKED HER WHERE SHE'D GO."

"PROBABLY, SHE'D GO TO THE BEACH...SHE'S SELL HER HATS RIGHT ON THE BEACH AND START A NEW LIFE...I NEVER ASKED ABOUT THE MONEY (I.E. HOW SHE WOULD PAY FOR A FLIGHT TO THE MAINLAND.) SHE SAID SHE COULD PAY FOR HIM (CHILD). AT THE TIME, SHE WAS STAYING AT HALE EWA..NO, HALAWA...ON WHAT STREET? I HAVE NO IDEA...(DET)NOJIRI FOUND THE STORE (WE WENT TO).I HAVE TO GO TO HONOLULU TO SEE OFFICER SELF AND OFFICER CAMERO...TO GO WITH THEM TO FIND THE STORE....."

(HX) SHE WAS LAST LIVING THERE AUGUST OR SEPT/97. SHE WAS LEAVING (HI) BECAUSE IT WAS "TOO MUCH (TOO COSTLY)..EVERYTHING IS TOO EXPENSIVE,HERE." (ASKED ABOUT THIS 'ROSE' HE REPEATEDLY ANSWERED, "I NEVER ASKED." "I COULDN'T FEED HIM. HE WANTED TO GO WITH AUNTIE...HE (PETER, JR) SAID "YES."

KEMA SR WAS ASKED, IF HE HAD A PET THAT HE COULD NOT PROVIDE FOR, WHAT WOULD HE DO?..KEMA SAID,"I'D TURN HIM OVER TO HUMANE SOCIETY..IT'S THEIR PROPERTY IF THEY (REFERENCE TO PUTTING THE PET TO SLEEP). I'D TURN HIM IN, GAS THE DOG OR PUT HIM TO SLEEP."

HE WAS ASKED WHETHER HE HAS A PICTURE OF ROSE...'NO'...

SUMMARY: THIS IS A 27 YEAR OLD MALE/PART HAWAIIAN, WHO DID NOT EXPRESS ANY REMORSE NOR TALK ABOUT ANY ALTERNATIVE ACTIONS WHICH HE COULD HAVE DONE FOR PETER JR. WHEN ASKED WHY HE DID NOT RETURN TO HIS HOME TO HIS WIFE AND THE ██████████, HE STATED THAT THEY WERE "SEPARATED" AND SUGGESTED THAT HE COULD NOT RETURN TO HER. HOWEVER, IT WAS POINTED OUT THAT HE DID RETURN TO HILO TO THE FAMILY HOME, BUT DID NOT BRING PETER JR. HE WAS UNWILLING TO GIVE

ANY FURTHER INFORMATION.
