SUBCHAPTER 1

GENERAL PROVISIONS

§19-122-1 Issuance of Hawaii driver's license.

(a) No Hawaii driver's license shall be issued unless the applicant:

- (1) Presents a valid instruction permit for the appropriate category, passes a practical test or tests for the appropriate category of motor vehicle, surrenders all driver's licenses in the applicant's possession, and if under the age of eighteen, meets all the requirements in section 19-139-152;
- (2) Possesses a valid license comparable to a category 1, 2, or 3 Hawaii driver's license and:
 - (A) Passes the vision test described in section 19-122-356;
 - (B) Passes the knowledge test described in section 19-122-10 for the appropriate category;
 - (C) Presents proof of name and date of birth;
 - (D) Presents social security card unless the examiner of drivers receives verification from the United States Social Security Administration stating the applicant is ineligible for a social security number;
 - (E) Passes a practical test or tests for the appropriate category of motor vehicle if the licensee:

- (i) Is under eighteen years of age; or
 - (ii) Is at least eighteen years of age and required by the examiner of drivers to demonstrate driving ability; and
 - (F) Presents all out-of-state licenses, one of which shall cover the category for which the applicant is applying; or
- (3) Possesses a valid commercial driver license and:
- (A) Passes the vision test described in section 19-122-356;
 - (B) Passes the hazardous materials test described in section 19-122-10 to retain a hazardous materials endorsement;
 - (C) Presents proof of name and date of birth;
 - (D) Presents social security card;
 - (E) Is at least twenty-one years of age;
 - (F) Presents all out-of-state licenses, one of which shall cover the category for which the applicant is applying; and
 - (G) Presents any of the following documents that contains the address of applicant's principal residence within the State of Hawaii:
 - (i) Hawaii vehicle registration or title issued at least thirty days before the application date;
 - (ii) Voter registration card;
 - (iii) Utility bill;
 - (iv) Checking or savings account statement not more than two months old;
 - (v) Payroll check or check stub issued by an employer within two months of the application date;
 - (vi) Mortgage account or proof of home ownership;
 - (vii) Residential rental contract;
 - (viii) School identification or document;

- (ix) United States income tax return from the previous year;
- (x) Hawaii income tax return from the previous year;
- (xi) Receipt for personal property taxes paid to a county within the State of Hawaii within the last year; or
- (xii) Other documents the examiner of drivers accepts as proof of residency in the State of Hawaii.

(b) The examiner of drivers may waive the motorcycle skills test if the applicant presents a "Notice of Satisfactory Course Completion", DOT 4-810 (7/01) as shown in Exhibit C, entitled "Motorcycle Skills Test Certification for Waiver", dated 7/1/04, located at the end of this chapter.

(c) The examiner of drivers may require that further physical and mental examinations be conducted upon the applicant as the examiner finds necessary to determine the applicant's fitness to operate a motor vehicle safely upon the highways.

(d) Before issuing a driver's license, the examiner of drivers shall obtain the applicant's clear driving status on the Commercial Driver License Information System, the National Driver Register Problem Driver Pointer System, and other data exchange applications to determine the applicant's identity and eligibility.

(e) An out-of-state licensee who possesses a valid license comparable to a Hawaii category 4 license and who desires a category 4 Hawaii driver's license shall comply with section 19-122-2. §19-122-2 Instruction permit required. All applicants shall obtain an instruction permit if they

are not licensed by the State of Hawaii or any other jurisdiction for the category of motor vehicle for which application is made.

All applicants possessing a valid driver's license from another jurisdiction which is comparable to a category 4 Hawaii driver's license and desiring to obtain a Hawaii category 4 license shall obtain an instruction permit for category 4. The applicant may also at the same time be issued a temporary driving permit for a category 1, 2, or 3 driver's license when the applicant's valid out-of-state category 4 driver's license covers the appropriate category 1, 2, or 3 license and meets all of the appropriate requirements set forth in section 19-122-4. As used in this chapter, categories of motor vehicles shall be as set forth in sections 286-102 and 286-239, Hawaii Revised Statutes. §19-122-3 Issuance of instruction permit. No instruction permit shall be issued to an applicant unless the applicant:

- (1) Passes the vision test described in section 19-122-356.
- (2) Passes a written, oral, or automated test pursuant to sections 19-122-10 and 19-122-11, determined by the examiner of drivers to be appropriate for the category of motor vehicle for which the applicant seeks to be licensed.
- (3) Presents proof of name and date of birth.
- (4) Presents social security card unless the examiner of drivers receives verification from the United States Social Security Administration stating the applicant is ineligible for a social security number.
- (5) Presents a current head front view color photograph, about 2" x 2" if applying for a commercial driver's instruction permit.

- (6) Meets the qualification standards of 49 CFR, Part 391, Subparts B and E if the applicant expects to obtain a category 4 or commercial driver's instruction permit.
 - (A) Class 4 applicants disqualified under 49 CFR 391.41(b)(3) may qualify by providing a signed statement that certifies the applicant is medically qualified and not a threat to public safety to operate a class 4 motor vehicle. The statement must be signed by the applicant's personal physician who, if not an endocrinologist or internist, must certify in the statement that a named specialist in endocrinology has been consulted.
 - (B) An applicant for a commercial driver's license who is not physically qualified under 49 CFR 391.41(b)(1) or (2) may qualify by providing a "Physical Disability Waiver," HWY-V 004 (5/04) as shown in Exhibit G, entitled "Certification for Physical Disability Waiver", dated 7/1/04, located at the end of this chapter.
 - (C) An applicant for a commercial driver's license who is not physically qualified under 49 CFR 391.41(b)(3) may qualify by providing an "Intrastate Medical Waiver," DOTH 2062(4/04) as shown in Exhibit H, entitled "Certification for Intrastate Medical Waiver", dated 7/1/04, located at the end of this chapter.
- (7) Shows a clear driving status on the Commercial Driver License Information System, the National Driver Register Problem Driver Pointer System, and other data exchange applications to determine the applicant's identity and eligibility.

- (8) Presents proof of residency in the State of Hawaii in accordance with section 19-122-1(a)(3)(G) to obtain a permit for a commercial driver's license. §19-122-4 Temporary driver license. Except as otherwise provided in section 19-122-353(f), a temporary driver license shall be issued only to a person who qualifies for a class 1, 2, 3, or 4 driver's license. The examiner of drivers may issue a temporary driver license valid for ninety days when experiencing network or system problems. §19-122-5 Renewal of driver's license. (a) No driver's license shall be renewed until the applicant has passed the vision test described in section 19-122-356. Applicants must pass the hazardous materials test described in section 19-122-10 to renew a hazardous materials endorsement.

The examiner of drivers may require further physical examinations and practical tests to be conducted upon the applicant as the examiner finds necessary to determine the applicant's fitness to continue to operate a motor vehicle safely upon the highways.

(b) Before renewing a driver's license, the examiner of drivers shall obtain the applicant's clear driving status on the Commercial Driver License

Information System, the National Driver Register Problem Driver Pointer System, and other data exchange applications to determine the applicant's identity and eligibility. §19-122-6 Reexamination after failure. If an applicant fails the knowledge or practical test, there shall be a mandatory waiting period of at least one week but not more than thirty days before the applicant shall be eligible for retesting. §19-122-10 Knowledge tests for original license.
(a) Applicants for an original Hawaii driver's license categories 1, 2, 3, and 4 shall take an appropriate examination in the English language on rules of the road, traffic code provisions, safe driving practices, and the meaning of traffic signs. At least three different sets of examinations, each consisting of not less than twenty-five general questions, shall be available for use by the examiner of drivers. Any one of the examination sets may be used at the discretion of the examiner. Each applicant shall be given one examination.

(b) Each applicant applying for a category 1 or 2 license (motorcycle or motor scooter) shall take a test as described in subsection (a) and an examination in the English language consisting of not less than ten questions pertaining to the operation of a motorcycle or motor scooter.

(c) Applicants who possess a valid Hawaii driver's license and make application for a higher category of driver's license shall not be required to take the examination described in subsection (a).

(d) Applicants for a commercial driver license shall take a general knowledge test about good driving practices and vehicle inspections to operate commercial vehicles safely. At least two sets of examinations, each consisting of fifty test items, shall be available for use by the examiner of drivers. Any one of the examinations may be used at the discretion of the examiner. Each applicant shall be given one examination.

(e) Commercial drivers shall take special knowledge tests to drive certain vehicles and to transport certain cargo. Two forms of each specialized test shall be made available for use by the examiner of drivers. The specialized tests are:

- (1) Air brakes test. This test measures knowledge required to drive vehicles equipped with air brakes. Each test shall consist of twenty-five questions.
- (2) Combination vehicles test. This test measures knowledge required to drive combination vehicles such as tractor-trailer rigs. It must be passed by every applicant who wants a category A commercial driver license. Each test shall consist of twenty questions.
- (3) Passenger transport test. This test measures knowledge required by bus drivers. It must be passed to receive a passenger endorsement (P) to a commercial driver license. Each test shall consist of twenty questions.
- (4) Doubles/triples test. This test measures

knowledge required to drive trucks with two or three cargo trailers. It must be passed to receive a doubles/triples endorsement (T) to a category A commercial driver license. Each test shall consist of twenty questions.

- (5) Tank vehicle test. This test measures knowledge required to drive tanker trucks that haul liquids or gases in bulk. It must be passed to receive a tank vehicle endorsement (N) to a commercial driver license. Each test shall consist of twenty questions.
- (6) Hazardous materials test. This tests basic knowledge of regulations governing the hauling of hazardous materials and hazardous waste. It must be passed to receive a hazardous materials endorsement (H) to a commercial driver license. Each test shall consist of thirty questions. An endorsement to carry hazardous materials in a tank vehicle is indicated by a (X).
- (7) School bus test. This test measures knowledge required to drive school buses. It must be passed to receive a school bus endorsement (S) to a commercial driver license.

(f) The applicant shall be considered to have passed a knowledge test if at least eighty percent of the questions have been answered correctly.

(g) An applicant who has difficulty reading the English language shall be examined orally or by other means deemed appropriate by the director in any of the knowledge tests except the hazardous materials endorsement test.

(h) An applicant who has difficulty understanding the English language may be examined in the language chosen from those available and approved by the director in any of the knowledge tests except the hazardous materials endorsement test. §19-122-11 Knowledge tests for renewal license. If the applicant for a renewal license wants to retain a hazardous materials endorsement, the applicant must take a special knowledge examination in the English language on how to recognize, handle, and transport hazardous materials. The examination shall consist of not less than thirty questions. The applicant shall be considered to have passed the knowledge test if at least eighty percent of the questions have been answered correctly. §19-122-12 Practical tests. (a) Practical tests shall be given as required under sections 19-122-1, 19-122-4, and 19-122-5. Practical tests shall be as set forth in sections 19-122-13, 19-122-14, and 19-122-17. §19-122-13 Off-street skill tests for motor scooters, motorcycles, and three-wheeled vehicles. (a) When required by the examiner of drivers to take off-street skill tests, an applicant for a category 1 license (mopeds) or a category 2 license (motorcycles and motor scooters) shall:

- (1) Provide for the test, a motor vehicle in serviceable condition of the category for which the applicant desires to be licensed;

- and
- (2) Obtain a passing score of zero to ten points after completing seven exercises administered in accordance with Section 2.0 of the Alternate MOST (Motorcycle Operator Skill Test) Examiner Study Guide as shown in Exhibit D, entitled "Alternate MOST Examiner Study Guide", dated 7/1/04, located at the end of this chapter. When a three-wheeled vehicle is used for the test, the following modifications to the test shall be made:
 - (A) Sharp turn. The boundary lines for the turn shall be two feet wider than the two tires beside one another to allow a foot on each side of the vehicle.
 - (B) Quick stop. Widen boundary lines for the timing zone by two feet.
 - (C) Obstacle swerve. Widen boundary lines for the timing zone and the lanes by two feet. (Eff 8/26/82; am 12/1/85; am and comp 6/15/91; am and comp 12/2/00; am and comp 11/30/02; am and comp 5/15/06] (Auth: HRS §§286-18, 286-108) (Imp: HRS §286-108)

§19-122-14 On-street skill test for category 3 light motor vehicles. (a) When required by the examiner of drivers to take an on-street test, an applicant for a category 3 license shall:

- (1) Provide for the test a motor vehicle in serviceable condition of the category for which the applicant desires to be licensed. The vehicle may be equipped with manual or automatic shift transmission.
- (2) Start the vehicle; drive through a business district; park parallel to a curb in a space provided; make proper right and left turns; exhibit skill in the use of the clutch or transmission when moving on a slight grade from a standing start whether proceeding

forward or reversing; operate the vehicle in reverse; observe, without hesitation, traffic signs and signals; drive through heavy traffic; exhibit proper braking procedures when coming to a stop and when following or driving through heavy traffic; and exhibit proper signaling of intention to turn or stop. If possible, the course shall include at least two stop signs and two traffic signals; a straight course to demonstrate the applicant's knowledge of signals; at least three right turns and three left turns incorporating all turning situations that the driver might encounter; and at least two unmarked intersections which may be of a type where the applicant's view of cross traffic is partially obscured. The route shall be planned to allow the examiner to rate the applicant's ability to read and interpret traffic signs and roadway marking; alertness and resistance to distractions; ability to size up difficult traffic situations and make intelligent decisions; and ability to apply knowledge of county traffic ordinances, state laws, and safe driving practices.

(b) An applicant shall be considered to have passed the on-street test if the applicant satisfactorily demonstrates the following:

- (1) Starting. The engine is started without difficulty and the vehicle is placed in motion smoothly.
- (2) Stopping. The vehicle is brought to a smooth and comfortable stop.
- (3) Steering and turning. The vehicle is kept on a steady course with no swaying in traffic. Left and right turns are executed in compliance with traffic regulations.
- (4) Reversing. The vehicle is maintained on a steady course. There is exhibited a satisfactory sense of direction while backing.

- (5) Observance of signs and signals. There is a strict adherence to traffic signs and signals, speed restrictions, and pedestrian right-of-way. Arm signal or mechanical signals signifying an intention to turn is given. Arm signal signifying an intention to stop is given.
- (6) Clutch synchronization and acceleration and deceleration. In a motor vehicle with a manual transmission, the application and release of the clutch is satisfactorily smooth and gradual when starting forward, reversing, or coming to a stop on level ground or an upgrade. In all motor vehicles, acceleration and deceleration is gradual and steady.
- (7) Brake reaction. When the brake is applied at a speed of twenty miles per hour, the distance between the point where the brakes are applied and the point where the vehicle comes to a complete stop is not more than twenty-five feet. Reaction time is not more than three-fourths of a second. Reaction time distance is twenty-two feet. The total stopping distance is forty-seven feet.
- (8) Parking. Parking is accomplished in a business district, both parallel to the right and to the left of a curbing within the space provided. There is a smooth unfaltering execution of the parking procedure, the applicant demonstrating reasonably good distance and timing judgment. §19-122-17 Category 4 and commercial driver license skill tests. (a) The skill tests include the vehicle inspection test, the basic control skills test, and the road test. The applicant shall provide a motor vehicle in the category the applicant desires a license. The applicant shall take the:

- (1) Vehicle inspection test by conducting a thorough inspection of the vehicle as shown in the Vehicle Inspection Guide, dated 7/1/04, located at the end of this chapter as Exhibit E.
- (2) Basic control skills test to demonstrate basic skills essential for safe control of the vehicle. Four of the following six exercises shall be taken; however, the director may approve test modifications for vehicles with more than one articulation. These exercises, entitled "Exercises for Basic Control Skills Test," dated 7/1/04, are shown at the end of this chapter as Exhibit F.
 - (A) Right Turn. The applicant shall drive forward and make a right turn around a cone or standard, bringing the rear wheels of the vehicle as close to the cone as possible without touching it.
 - (B) Forward Stop. The applicant shall drive through the alley and stop as close as possible to the stop line at the end.
 - (C) Straight Line Backing. The applicant shall back down and out of the alley, without touching the boundaries of the alley.
 - (D) Alley Dock. The applicant shall drive by the alley so the entrance is on the applicant's left. The applicant shall back into the alley, without touching the boundaries of the alley, and stop within two feet of the rear of the alley.
 - (E) Sight-side or Conventional Parallel

Park. The applicant shall park in a space that is on the applicant's left or right as close as possible to the rear and the "curb" of the space without crossing the lines or hitting the cones.

- (F) Backward Serpentine. The applicant shall start with the vehicle lined up near the first cone so that the applicant can drive forward along the right side of cones. The applicant shall drive forward and stop when the rear of the vehicle is past the third cone. The applicant then shall back up so the vehicle winds around the three cones, passing the third cone so the cone is on the left, the second cone so the cone is on the right, and the first cone so the cone is on the left. After threading back through the cones, the vehicle ends up in the same position it started from.

- (3) Road test to demonstrate ability to drive safely in most on-the-road situations. The predetermined route should contain the following maneuvers: four left and four right turns; a straight section of urban business street; intersections; a railroad crossing (or simulation); one curve; a section of expressway or two-lane rural or semi-rural road; a downgrade; a simulated downgrade; an upgrade; a downgrade for stopping; an upgrade for stopping; and one underpass, low clearance, or a bridge.

(b) The scoring form for the Pretrip Inspection, Basic Control Skills test and Road test is shown in Exhibit A (DOT 4-558, MVS 5/01 and DOT 4-579, MVS 8/01) dated 7/1/04, located at the end of this chapter.

(c) The applicant shall be considered to have passed each test if the applicant received passing scores as shown in Exhibit B (Model CDL Examiner's Manual, v2.0,7/95), entitled "CDL Performance Tests

Passing Scores," dated 7/1/04, located at the end of this chapter.

(d) The applicant shall pass the skills test in a vehicle equipped with air brakes to obtain an unrestricted license.

- (3) Blood pressure readings at rest, sitting, and standing; and
- (4) Elevated blood pressure, medication for hypertension, or other evidence of any cardiovascular abnormality will require a maximal exercise stress EKG;
- (5) Ophthalmologic or optometric confirmation of stable visual acuity (at least 20/40 in each eye separately), with or without corrective lenses, and absence of active or untreated

- proliferative diabetic retinopathy;
- (6) Examination and tests to detect peripheral neuropathy or circulatory deficiencies of the extremities or both; and
 - (7) Evaluation of insulin dosages and types, diet utilized for control, and any significant factors such as smoking, alcohol use, and other medications or drugs taken.
- (e) The examining endocrinologist or internist shall certify that the applicant under this section:
- (1) Has been using insulin to control the applicant's diabetes prior to the date of the application as follows:

The purposes of subchapter 8 are to establish procedures for the application for the issuance of a driver's license or permit to persons with medical conditions that could affect their ability to safely operate a motor vehicle, and to provide for vision standards, procedures, and tests for the issuance or renewal of a driver's license or permit. §19-122-351 Definitions. As used in this subchapter, unless a different meaning clearly appears in the context:

"Applicant" means a person who is attempting to obtain a driver's license, license renewal, or permit;

"Examiner of drivers" means the person or authorized representative of the examiner of drivers, as provided in section 286-101, HRS;

"Medical Advisory Board" means the board of medical advisors, as provided in section 286-4.1, HRS;

"Medical doctor" means licensed medical doctor or doctor of osteopathy;

"Medical report" means a report submitted on form DOT-H 2058 (12/06) as shown in Exhibit I;

"Reasonable cause" means the belief, which is fair, proper, just, moderate and suitable under the circumstances. [Eff and comp **MAY 02 2008**] (Auth: §§286-18, 286-102) (Imp: §286-102)

§19-122-352 Sources of information reporting medical condition. (a) The examiner of drivers has reasonable cause to believe written information that is received from:

- (1) Federal, state or county police authorities;
- (2) Licensed medical doctors and optometrists;
- (3) Federal or state courts; or
- (4) Examiner of drivers or authorized representatives of the examiner of drivers.

(b) Upon receipt of such information, the examiner of drivers may initiate the appropriate action. [Eff and comp **MAY 02 2008**] (Auth: §§286-18, 286-104, 286-106, 286-107, 286-110, 286-119, 286-137) (Imp: §§286-104, 286-106, 286-107, 286-110, 286-119, 286-137)

§19-122-353 Examination of applicant or licensee

(a) The examiner of drivers will include, as part of the application for a driver's license, renewal or permit, questions as to the existence of physical or mental conditions which may impair the ability of the applicant to operate a motor vehicle safely or which make such operation hazardous to the public safety. These questions must be answered by each applicant for a driver's license or permit and by each licensee seeking renewal of a driver's license.

(b) If the answer to any such question indicates the existence of any physical or mental condition that the examiner of drivers determines may prevent the applicant from safely operating a motor vehicle, the examiner of drivers may require an examination of the applicant by a licensed physician or any other competent authority acceptable to the examiner of drivers.

(c) If the examiner of drivers has reasonable cause beyond self-disclosure on the application form to believe that an applicant has a medical condition which may prevent the applicant from safely operating a motor vehicle or which makes such operation hazardous to public safety, the examiner of drivers may require a completed medical report and other examinations and

reports by a licensed medical doctor or any other competent authority acceptable to the examiner of drivers.

(d) The cost of such examinations must be borne by the person whose fitness to operate a motor vehicle safely is in question.

(e) The examiner of drivers may issue a temporary permit up to one year duration, with restrictions, which must include a restriction against driving on highways, to applicants who have successfully completed their initial driver rehabilitation assessment.

(f) Pending submission of required examinations the examiner of drivers may adopt and issue a ninety-day temporary license to a licensee. The examiner of drivers may extend the license for an additional ninety days for good cause. If the medical report is received within six months from the date of the physical, mental or visual examination, the examiner of drivers will evaluate the applicant and may issue or deny the license, with or without restrictions and require the surrender of the applicant's existing license or permit.

(g) The examiner of drivers may use the results of any physical or mental examinations or reports only to determine the physical or mental competency of the person for the purpose of revoking, suspending, allowing a voluntary surrender and canceling, denying or issuing a driver's license or permit. This information is privileged and may be released only to the person examined, to the Medical Advisory Board, to the attorney or other authorized persons of the person examined, pursuant to a court order or to the hearing officer upon the person's written request for a hearing. Upon notification, the licensee or permittee shall surrender the driver's license or permit within ten business days. Notice of cancellation and surrender of license or permit shall be deemed received ten days after mailing.

(c) The licensee may apply for a reinstatement of the applicant's driver's license or permit if the applicant presents medical evidence satisfactory to the examiner of drivers that the applicant is physically or mentally capable, or both, of operating a motor vehicle safely. §19-122-356 Vision standards. (a) Each applicant shall meet the minimum standards of vision to qualify for a permit or license. Failure to meet the minimum standards of vision shall result in the applicant not being licensed to drive. Where the tests indicate a restriction is appropriate, the permit or license shall be subject to the appropriate restrictions established under section 19-122-358. All restrictions shall be noted on the driver's license. The minimum standards for applicants of a category 1, 2, or 3 driver's license shall be:

- (1) Visual acuity. The applicant shall have 20/40 (Snellen) or better vision in one eye, corrected or uncorrected; and
- (2) Peripheral vision or the horizontal vision field. The applicant shall have the ability to see a field of vision of seventy degrees or more using one eye.
- (b) The minimum standards for a category 4 or commercial driver license shall be:
 - (1) Visual acuity. The applicant shall have at least 20/40 (Snellen) in each eye without corrective lenses or visual acuity separately corrected to 20/40 (Snellen) or better with corrective lenses;
 - (2) Distant binocular acuity of at least 20/40 (Snellen) in both eyes with or without corrective lenses;
 - (3) Field of vision of at least 70 degrees in the horizontal meridian in each eye; and
 - (4) The ability to recognize the colors of traffic signals and devices showing standard red, green and amber. [Eff and comp

§19-122-359 Requirement to submit medical report.

(a) A person who has experienced any of the following physical or medical conditions, and who is applying for or renewing a driver's license or who is requested by the examiner of drivers to obtain a medical examination, must submit a written medical report describing the condition and its effect on the person's ability to operate a motor vehicle safely:

- (1) Any person who experiences a lapse of consciousness occurring within the last two years as a result of a condition which can cause a lapse of consciousness, including,

without limitation, epilepsy, diabetes, frequently reoccurring fainting or dizzy spells caused by major medical problems and major head injuries or any other injuries or conditions resulting in lapses of consciousness.

- (2) Any person having a cardiovascular condition or related condition occurring within the last two years which may interfere with the ability of the person to operate a motor vehicle safely, including, without limitation, myocardial infarction, angina pectoris, coronary insufficiency, thrombosis or any other cardiovascular disease of a variety known to be accompanied by syncope, dyspnea, collapse or congestive cardiac failure.
- (3) Any person who has a mental, nervous or functional disease or psychiatric disorder, which is likely to interfere with his ability to safely operate a motor vehicle.
- (4) Any person who has an established medical history or clinical diagnosis of rheumatic, arthritic, orthopedic, muscular, neuromuscular or vascular disease which may interfere with the ability to control and safely operate a motor vehicle.
- (5) Any person who has an established medical or clinical diagnosis of chronic alcoholism or drug addiction.
- (6) Any applicant who fails the vision test as set forth in section 19-122-356.
- (7) Any person who the examiner of drivers has reasonable cause to believe has a medical condition which may interfere with the safe operation of a motor vehicle.
 - (b) The completed medical report must indicate whether the condition of the applicant and any medication prescribed for the applicant would affect the applicant's ability to safely operate a motor vehicle.

(c) The medical report is valid for no more than six months from the date of the physical or mental examination, unless the medical advisory board recommends a more current report.

(d) The examiner of drivers may use the results of any physical or mental examinations or reports only to determine the physical or mental competency of the person for the purpose of revoking, suspending, allowing a voluntary surrender and canceling, denying or issuing a driver's license or permit. This information is privileged and may be released only to the person examined, to the Medical Advisory Board, to the attorney or other authorized persons of the person examined, pursuant to a court order or to the hearing officer upon the person's written request for a hearing. §19-122-360 Medical advisory board. (a) The medical advisory board shall be established within the office of the State Director of Transportation, for administrative purposes, and shall consist of no fewer than five physicians licensed to practice in the State. The members of the board shall be appointed by the governor as provided in Section 26-34, HRS, except as otherwise provided by this subchapter: one psychiatrist, one neurologist, one orthopedic surgeon, one ophthalmologist or optometrist, and one specialist in cardiovascular disease. The members of the board shall serve without compensation, but shall be reimbursed for expenses, including travel expense, actually incurred in the performance of their duties under this subchapter.

(b) The medical advisory board shall:

- (1) Assist the examiner of drivers or authorized representative by developing medical and health standards and a system for medically evaluating persons, for use in the issuance of driver's licenses; and

(2) Provide recommendations to the examiner of drivers in an advisory capacity on the ability of persons with medical conditions to safely operate a motor vehicle.

(c) The examiner of drivers or authorized representative may request an advisory opinion or recommendation from the medical advisory board if the permit or license of any person applying for a driver's license, permit, or renewal of either privilege has been suspended, revoked, cancelled or denied pursuant to the provisions of Hawaii Revised Statutes (HRS) 286-119, or if the examiner of drivers has reasonable cause to believe that such person suffers from a medical condition that may affect such person's ability to safely operate a motor vehicle.

(d) The medical advisory board may use medical and examination reports submitted to or requested by the medical advisory board only to determine the medical condition of an applicant. Reports of the medical advisory board may be admitted in proceedings under the provisions of the State's contested hearings, Chapter 91 of the Hawaii Revised Statutes, and the rules and regulations relating to hearings of the examiner of drivers of each respective county within this State.

(e) The medical advisory board shall meet on the second Monday of each month. Should the second Monday fall on a recognized state holiday, the medical advisory board shall meet on as close as practicable to the second Monday of the month. [Eff and comp MAY 02 2008

§19-122-361 Restrictions related to a Medical Condition. The examiner of drivers may adopt and impose restrictions as shown in Exhibit J, dated 12/06, and compulsory requirements when licensing persons to drive a category 1, 2 or 3 driver's license. A driver's license shall not be issued and a driving test shall not be conducted until the applicant complies with the provisions of this section. The examiner of

§19-122-362 Denial of license: Medical conditions. If one or more of the following medical conditions exist and there is documented evidence through medical examinations or reports in addition to appropriate departmental evaluations and examinations which indicate the disorder would severely impair the person's ability to safely operate a motor vehicle, the examiner of drivers will not issue or renew the license, permit or privilege. The existence of one of these conditions does not automatically preclude the applicant from obtaining a license if the condition is not severe enough to impair the applicant's driving ability:

- (1) Lapses of consciousness, severe dizziness, fainting spells, head injuries, seizures or any other injuries or conditions resulting in lapses of consciousness, including, without limitation, epilepsy or disorders related to or associated with diabetes. A person suffering from lapses of consciousness or any other disorder as specified above will not be issued a license until the applicant submits to the examiner of drivers a medical report signed by the applicant's medical doctor which states that:
- (a) Applicant has been free of seizures or has not suffered any fainting or dizzy spells or other such disorders for a period of 6 months; or
 - (b) The seizure or other condition resulting in the lapse of consciousness was an isolated incident and is unlikely to reoccur.

The medical report must also state whether any medication prescribed for the person will

interfere with the ability of the person to operate a motor vehicle safely and the date of the most recent seizure or lapse of consciousness.

- (2) Any cardiovascular condition or related condition such as myocardial infarction, angina pectoris, coronary insufficiency, thrombosis or any other cardiovascular disease of a variety known to be accompanied by syncope, dyspnea, collapse or congestive cardiac failure.
- (3) Any mental, nervous or functional disease or psychiatric disorder, which is likely to interfere with applicant's ability to safely, operate a motor vehicle.
- (4) Any established medical history or clinical diagnosis of rheumatic, arthritic, orthopedic, muscular, neuromuscular or vascular diseases that may interfere with applicant's ability to safely operate a motor vehicle.
- (5) Any established medical or clinical diagnosis of chronic alcoholism or drug addiction.
- (6) Inability to meet the minimum vision standards established by the examiner of drivers.
- (7) Any physical or mental condition which impairs the ability of the person to operate a motor vehicle safely and which:
 - (a) Affects perception;
 - (b) Affects consciousness, including, without limitation, epilepsy;
 - (c) Alters judgment, or
 - (d) Limits motion. [Eff and comp

§19-122-363 Reinstatement of license or issuance after denial; submission of information regarding hazard to public welfare. (a) If a person who, for

medical or physical reasons or because the person's licensing would be hazardous to public safety, has been denied a license or permit, or has had a license suspended, revoked or cancelled subsequently applies for issuance or reinstatement of the license or permit, the person may be required to submit the following information:

- (1) A current statement concerning the condition by any treating medical doctor or other competent authority acceptable to the examiner of drivers. The medical statement must include the diagnosis, treatment and prospect of recovery from or control of the condition.
- (2) A current medical report covering the results of any medical examinations pertinent to the condition in question.
 - (b) The examiner of drivers may consider approval recommended by the medical advisory board, when applicable, and any other information the examiner of drivers deems relevant.
 - (c) The examiner of drivers or authorized representative may, in addition, require the applicant or licensee be given a driving test and other examinations which are deemed necessary to effectively evaluate the ability of the applicant or licensee to operate a motor vehicle safely.
 - (d) The examiner of drivers may require any or all of the information specified in this section, together with any other information deemed relevant in any case in which the issue arises as to whether the driving of a motor vehicle by a person would be hazardous to the public welfare. §19-122-364 Hearings. (a) A licensee has 30 days after the effective date of a suspension, revocation or cancellation of a license or permit, the denial of an application or imposition of a restricted license to petition the examiner of drivers for a

(b) Upon request for the hearing, the applicant or licensee shall provide all available information necessary to determine the fitness of the applicant or licensee to operate a motor vehicle safely, including the licensee's or applicant's statement of his or her case history, any treating physician's statement as to the diagnosis, treatment and prospect of recovery from or control of the condition and any other information deemed necessary by the hearing officer. 2.0 CUSTOMER INFORMATION

Every customer should understand what will be required and how the test will be scored. There is nothing to be gained by concealing the nature of the exercises.

If a modification is required to lay out the test, the instructions should be reviewed to be sure the content is correct.

The instructions explain what is expected; therefore, the customer may watch and listen while others take the test.

2.1 TEST ADMINISTRATION

2.1.1 PRE-TEST

Instructions

- This test consists of seven exercises that measure your ability to perform basic vehicle-control and hazard-response skills. Most of the exercises involve speeds of about 15 mph. You will be scored on time and distance standards, as well as path and foot-down violations. The test may be ended for point accumulation, falling or dropping the motorcycle, committing an unsafe act, or failure to understand or follow instructions. You may stop the test at any time. However, you must complete the entire test to pass it. Do you have any questions?

(Point out the path of travel as you read the instructions for each exercise.)

2.1.2 EXERCISE ONE—STALLS ENGINE

Purpose

Stalling indicates a rider's lack of clutch and throttle control. If unable to coordinate these controls, a rider could stall in traffic, creating an unsafe situation.

Examiner Position and Action

Instructions for Stalling, the Sharp Turn and the Normal Stop are given at the beginning of the first run. Stand on the rider's left.

Instructions

• Points are assessed if you stall your engine during any exercise. Do you have any questions?

Scoring

Riders are always scored according to the greatest degree of error. Maximum points for stalling is 5 points.

- Stalls engine once 1 point
- Stalls engine twice 3 points
- Stalls engine three or more times 5 points

Standard

Points are scored for stalling while attempting any exercise.

2.1.3 EXERCISE TWO—SHARP TURN

(See Illustration A on Page 8)

Purpose

Occasionally riders are required to make sharp turns into traffic. This exercise evaluates a rider's ability to maintain control and remain within a specific path when turning sharply.

Examiner Position and Actions

Stand to the rider's left to allow the rider to see the path of travel and hear instructions. After the rider leaves the starting T, move closer to the Sharp Turn to watch for violations. Cross to the other side of the course and stand near the Normal Stop box as the customer rides toward it. Keep your eyes on the tires and feet.

Instructions

• Accelerate straight ahead and make a sharp left turn inside the boundaries. Do not put a foot down or touch the lines.

Scoring

Maximum score for Exercise 2, Sharp Turn, is 6 points.

Check	Possible Points	Maximum Points
A. Path	0, 3, 5	5
B. Foot Down	0, 1	$\frac{1}{6}$

Standard

A. Path—One tire touches or crosses one boundary, 3 points. One tire touches or crosses two or more boundaries, or both tires touch or cross one or more boundaries, 5 points. If the motorcycle is near the outside of the path, pay attention to the outside line. If near the inside boundary, watch the inside line; the rear tire is more likely to touch a boundary. Watch the pavement! Score only when paint can be seen beside the tire, which indicates the tire is on the line.

B. Foot Down—One point is scored if one or both feet touch the ground.

2.1.4 EXERCISE THREE—NORMAL STOP

(See Illustration A on Page 8)

Purpose

This exercise evaluates a rider's ability to stop in a designated area, such as before a crosswalk or stop sign, without interfering with traffic.

Examiner Position and Action

After the rider completes the "Sharp Turn," the examiner moves from the barrier line, S, to the stop box, F. The examiner never takes his/her eyes off the rider.

Instructions

- Then ride toward this end of the course. Make a smooth, non-skidding stop with your front tire inside that box. Your front tire must not touch any painted lines.
- Do you have any questions? Wait for my signal to begin.

Check the stopped position. Reposition the rider for the next exercise. Mark the scoresheet and check point accumulation.


Scoring

Maximum score for Exercise 3, Normal Stop, is 8 points.

Standard

- A. Listen and watch for a skid. A skid is indicated by a locked rear wheel while the motorcycle is still in motion. A skid may or may not make a "chirp" or sliding noise. Assess 3 points.
- B. Stopped Position—Score from the first complete stop. Assess 5 points if the front tire touches a line or the contact point (where the bottom of tire rests on pavement) is not in the box.

2.15 EXERCISE FOUR—CONE WEAWE

(See Illustration B on Page 9)

Purpose

New riders must be familiar with motorcycle controls and basic handling skills. A rider may never experience this on the street as there is nothing to simulate a Cone Weave in the normal traffic experience. But a rider must be able to coordinate clutch and throttle to complete turns and avoid hazards.

Examiner Position and Actions

Instructions for the Cone Weave and U-Turn are given before the Cone Weave. Position the rider with the front tire on the T. Stand to the rider's right to allow the applicant to see the path of travel and hear instructions. When the rider starts, step behind and follow to the end of the U-Turn boundary line. Stay to the center of the cones to see if either foot touches the ground or if a tire skips or hits a cone. Once the rider is beyond the last cone, move to position F to see the U-Turn clearly.

Instructions

- Ride to the left of the first cone, to the right of the second, and so on. Weave past all five cones without touching or skipping a cone or putting your foot down.

Scoring

Maximum score for Exercise 4, Cone Weave, is 10 points.

A. Skips or hits cone(s)	0, 3, 5	5
B. Foot down	0, 3, 5	<u>5</u> 10

Standard

- A. Skips or hits cone(s) — A tire hits or skips one cone, 3 points. Two or more, 5 points.
- B. Foot down — One foot touches, 3 points. One or both feet touch two or more times, 5 points. Both feet touch at the same time, 5 points.

If a customer rides straight through cones 1-4, assess 5 points for "skips cones" only.

2.1.6 EXERCISE FIVE—U-TURN

(See Illustration B on this page)

Purpose

The U-Turn tests a rider's ability to coordinate multiple controls while negotiating a turn.

Examiner Position and Action

Instructions for the U-Turn are given with the instructions for the Cone Weave. As the rider leaves the Cone Weave, the position is approximately even with the barrier line. Start moving to the right, without interfering with the rider approaching the U-Turn. As the rider enters the U-Turn box, stand at the far end of the barrier line facing the rider. Watch the lines, not the motorcycle. The back line or exit sideline are most likely to be touched. Stand on the rider's right.

Instructions

- Continue around to the far side of the course and make a right U-Turn inside this box.
- Do not touch the solid line (motorcycles over 500cc) or the dashed line (motorcycles 500cc or under) or put a foot down.
- Stop near that line. Wait for further instructions.
- Do you have any questions? Wait for my signal to begin.

Scoring

Maximum score for Exercise 5, U-Turn, is 10 points.



2.1.7 EXERCISE SIX—QUICK STOP

(See Illustration C on Page 10)

Purpose

Approximately 70% of all accident-involved riders fail to use, or incorrectly use, their brakes in an emergency situation. The Quick Stop exercise measures a rider's ability to stop quickly.

Examiner Position and Actions

Stand to the rider's right and give instructions where the U-Turn ends near the obstacle-line for Exercise Seven, Obstacle Swerve. The rider begins with the front tire on the starting T located at the opposite end of the course. To score, the examiner should stand out of the path of travel and straight out or behind the second timing line, near the Cone Weave. Watch the lines. Start timing when the front tire reaches the first line. Stop timing when the front tire reaches the second line.

To score, walk to the stopped position and mark the stopping distance from the leading edge of the front tire. Record the "stopping distance" in the space on the scoresheet. Enter the time shown on the stopwatch. Use the timing/distance chart (page 12) to determine stopping distance allowed. Record this in the "allowed" space. Subtract distance "allowed" from actual stopping distance.

Instructions

- Position your cycle on that T.
- On my signal, accelerate straight up this path. Stabilize your speed between 12-20 mph by the time you reach the first line.
- Maintain a steady speed.
- When your front tire passes the second line, stop as fast as you safely can. You will not lose points if you skid.
- Remain stopped until I tell you to move.
- Do you have any questions? Wait for my signal to begin.

Scoring

Maximum score for Exercise 6, Quick Stop, is 5 points.

Check	Possible Points	Maximum Points
A. Stopping Distance	0, 1, 2, 3, 4, 5	5

Standard

A. Stopping distance—Use the 1' increments on the pavement to mark the leading edge of the front tire to the nearest foot. Assess one point for each foot beyond the standard up to a maximum of 5 points.

If the customer rides above 20 mph but stops within 23' (the standard for 20 mph), 0 points are assessed. The customer exceeded stopping standards set for novice riders.

B. Re-rides—A maximum of one re-ride is allowed for the following reasons:


- The speed range is 12-20 mph. If the rider's speed is over 20 mph on the first attempt and stops beyond 23', allow a second attempt. Advise the rider to ride between 12-20 mph. If it occurs again, assess 5 points.
- If speed is under 12 mph on the first run, the exercise must be repeated. Assess 5 points if it occurs again for failure to meet minimum standards.
- Braking in the timing zone requires a second attempt. Assess 5 points if it occurs again.

2.18 EXERCISE SEVEN OBSTACLE SWERVE

(See Illustration D on this page)

Purpose

Research has shown that 32% of accident-involved riders fail to take any evasive action and 76% improperly execute their evasive action. The Obstacle Swerve exercise evaluates a rider's ability to maneuver quickly to avoid a hazard.

Examiner Position and Actions

To score, stand out of the path of travel and behind the second timing line on the side the rider will be swerving. Position to clearly see both timing lines and a direct view of the sideline.

Instructions

Instructions are given where the Quick Stop ends. Roll the motorcycle back from its stopped position to permit seeing the obstacle line before reading the instructions. If necessary, advise the customer to ride slower or faster based on the previous exercise speed. Give the instructions from the side the rider will swerve.

- Start at the T.
- On my signal, accelerate straight up this path. Stabilize your speed between 12-20 mph by the time you reach the first line.
- Maintain a steady speed.
- When your front tire passes the second line, swerve to the (right/left). Avoid the obstacle line and stay to the inside of the side line. Do not touch either line.
- Once past the side line, stop and wait for further instructions.
- Do you have any questions? Wait for my signal to begin.

Scoring

Maximum score for Exercise Seven, Obstacle Swerve, is 5 points.


A. Path—A tire touches the obstacle line or side line, or the rider swerves in the wrong direction, is 5 points. If the rider performs this exercise properly at more than 20 mph, 0 points are scored.

Re-rides

Second runs are allowed for speeds too fast (if a path violation occurs), too slow, swerving or braking in the timing zone. Maximum points are assessed if any of these situations occur on the second attempt.

2.1.9 EXERCISE SIX: SEVEN-TIMING ZONE

Speed is calculated with a stopwatch and a timing chart. Watch the lines, not the motorcycle. When the front tire touches the first timing line, the stopwatch button is pressed and released. It is pressed and released again when the second timing line is touched. Compare the time on the watch with the chart to calculate stopping distance allowed.

Examiner position for all timing activities must be at the same place, every time, to maintain timing accuracy.

The following chart is for a 44' timing zone. **THIS TIMING ZONE SHOULD NOT BE USED WITHOUT A RUNNING START** of at least 25'.

2.2 TEST TERMINATION

The examiner is required to end the test under any of the following conditions:

- Point accumulation constitutes failure—Each skill-test exercise is increasingly more difficult and critical to safe operation than the previous exercise. Performing exercises after a rider has failed the test is hazardous for the unskilled operator.
- Falls or drops the motorcycle—Falling with or dropping the motorcycle indicates an inability to operate a motorcycle safely. Dropping is indicated when any portion of the side of the motorcycle touches the ground.
- Commits an unsafe act—An unsafe act could result from a rider's inability to perform exercise requirements (loses control if one wheel rises off pavement) or from a rider's attempt to demonstrate skills not called for in the exercise (disregard for instructions).
- Fails to understand or follow instructions—A rider may fail to understand instructions on a given exercise. Failure to comply with exercise instruction after two attempts is an automatic failure.
- Excessive test time—If, in the examiner's judgment, testing time has exceeded a reasonable limit, the test should be ended. Time may be excessive due to the rider stalling the cycle, having to continually repeat instructions, or misunderstanding instructions on various exercises:

The entire test must be administered when re-testing.

2.3 CUSTOMER DEBRIEFING

Customers should be advised of their score. It is recommended that the rider be given a copy of the scoresheet. The examiner should briefly explain points assessed. The skill level required to pass this test represents minimum, novice level skills. Anyone unable to meet those standards may need basic riding instruction. If available, test failures should be referred to a local rider-education course.

2.4 SCORESHEET

Points for errors made should be assessed after each exercise is completed. Once the applicant exceeds 10 points, the test should be ended.

Exercises 3 and 4 require the use of the Timing/Distance Chart. It converts speed to maximum allowable stopping distance.

Pre-test instructions on the scoresheet should be read to the customer. The customer signs the scoresheet, verifying the instructions were given.

ALTERNATE MOST INSTRUCTIONS

This test consists of seven exercises that measure your ability to perform basic vehicle-control and hazard-response skills. Most of the exercises involve speeds of about 15 mph. You will be scored on time and distance standards, as well as path and foot-down violations. The test may be ended for point accumulation, falling or dropping the motorcycle, committing an unsafe act, or failure to understand or follow instructions. You may stop the test at any time. However, you must complete the entire test to pass it. Do you have any questions? (*Point out paths of travel as you read instructions.*)

STALLS, SHARP TURN, NORMAL STOP—(*Stand on rider's left*)

- Points are assessed if you stall your engine during any exercise. Do you have any questions?
- Accelerate straight ahead and make a sharp left turn inside the boundaries. Do not put a foot down or touch the lines.
- Then ride toward this end of the course. Make a smooth, non-skidding stop with your front tire inside that box. Your front tire must not touch any painted lines.
- Do you have any questions? Wait for my signal to begin.

CONE WEAVE, U-TURN—(*Stand on rider's right*)

- Ride to the left of the first cone, to the right of the second, and so on. Weave past all five cones without touching or skipping one, or putting your foot down.
- Continue around to the far side of the course and make a right U-turn inside this box.
- Do not touch the solid line (*motorcycles over 500cc*) or the dashed line (*motorcycles 500cc or under*), or put your foot down.
- Stop near that line. Wait for further instructions.
- Do you have any questions? Wait for my signal to begin.

QUICK STOP—(*Stand on rider's right*)

- Position your cycle on that T.
- On my signal, accelerate straight up this path. Stabilize your speed between 12-20 mph by the time you reach the first line.
- Maintain a steady speed.
- When your front tire passes the second line, stop as fast as you safely can. You will not lose points if you skid.
- Remain stopped until I tell you to move.
- Do you have any questions? Wait for my signal to begin.

OBSTACLE SWERVE—(*Stand on side rider will swerve*)

- Start at the T.
- On my signal, accelerate straight up this path. Stabilize your speed between 12-20 mph by the time you reach the first line.
- Maintain a steady speed.
- When your front tire passes the second line, swerve to the (right/left).
- Avoid the obstacle line and stay to the inside of the side line. Do not touch either line.
- Once past the side line, stop and wait for further instructions.
- Do you have any questions? Wait for my signal to begin.






Figure 2-5. Straight Truck/School Bus




Figure 2-6. Coach/Transit Bus



Restriction B - Outside rear view mirrors	This restriction is placed on the driver's license of a person who meets the minimum vision standards with the aid of outside mirrors, whose hearing is impaired, or whose head or neck mobility is limited.
Restriction C - Automatic transmission	This restriction is placed on the driver's license of a person who because of physical limitations or impairments is unable to operate a manual transmission vehicle.
Restriction D - Daylight hours only	This restriction is placed on the driver's license of a person who is unable to operate a motor vehicle at night due to physical limitations or impairments.
Restriction E - Full hand	This restriction is placed
