Designed for tough cleaning, disinfecting and sanitizing of non-porous, hard surfaces in the bathroom. Cleans, shines, deodorizes, disinfects and sanitizes non-porous, hard surfaces such as bathtubs, sinks, shower stalls and toilet seats. May be used on non-porous, hard surfaces such as fiberglass, chrome, plastic, baked enamel and glazed porcelain.

► *Not recommended for brass or natural marble.*

Deodorizes those areas which generally are hard to keep fresh smelling, such as garbage storage areas, empty garbage bins and cans, basements, restrooms and other areas which are prone to odors caused by microorganisms.

***SANITIZES:** Kills 99.9% of *Escherichia coli*, *Klebsiella pneumoniae*, *Proteus vulgaris*, *Serratia marcescens*, *Staphylococcus aureus* (Staph) and Vancomycin-Resistant *Enterococcus faecalis* (VRE), on hard non-porous, non-food contact surfaces with a 5 minute contact time.

When used as directed, this product demonstrates effective disinfection against *Pseudomonas aeruginosa*, *Salmonella enterica* and *Staphylococcus aureus*. Efficacy tests have demonstrated this product is an effective one-step cleaner/disinfectant in the presence of organic soil (5% blood serum).

Kills *Trichophyton mentagrophytes*, the cause of Athlete's foot fungus, on hard, non-porous surfaces found in bathrooms.

DIRECTIONS FOR USE: It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

DISINFECTION, DEODORIZATION & CLEANING:

- SHAKE CAN WELL BEFORE AND DURING USE.**
- Holding can 6 to 8 inches from surface, spray area until it is covered with a white foam. To disinfect, allow foam to penetrate and remain wet for 10 minutes. To only clean surface, wipe foam away after 1 to 2 minutes.
- Wipe with wet cloth or sponge.
- For heavily soiled areas, remove heavy soil or gross filth before treatment.

TO SANITIZE: Spray hard non-porous surfaces until entire area is thoroughly covered with a white foam. Allow foam to remain wet for 5 minutes before wiping. Remove heavy soil or gross filth prior to sanitization.

TO KILL BACTERIA on hard, non-porous surfaces, spray surface until covered with a white foam and allow foam to penetrate. Let stand for 5 minutes, then wipe clean.

MOLD & MILDEWSTAT: To control mold and mildew on pre-cleaned, hard, non-porous surfaces such as floors, walls and table tops, spray the surfaces to be treated. Make sure to completely cover surfaces with foam. Let air dry. Repeat application at weekly intervals or when mildew growth reappears.

PRECAUTIONS BEFORE USE:
This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. 
