

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

Pesticide Storage: Store in original, tightly closed containers below 30°C (86°F) and above 0°C (32°F) in a secure area inaccessible to children and away from food or feed.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Handling: Nonrefillable container. Do not reuse or refill this container. **Commercial and Industrial Containers**

Container Disposal: (For containers less than 5 gallons:) Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. And drain for 10 seconds after the flow begins to drip. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer the recycling if available or puncture and dispose in a sanitary landfill, or by other procedures approved by state and local authorities.

(For containers more than 5 gallons:) Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Repeat this procedure two more times. Then offer for recycling or reconditioning if available or puncture and dispose in a sanitary landfill, or by other procedures approved by state and local authorities.

Commercial and Industrial Uses: This pesticide is toxic to fish.
