



FIRST AID



Apply contents of one tube of EasySpot® for Cats as a spot between the shoulder blades. Hold the cat for a few seconds to give the solution time to be absorbed into the cat's coat. When finished, wrap the tube in paper and put into the trash. Only one applicator per treatment is needed.
