**FIRST AID:**

Carefully peel off the foil covering from the Conceal™ and place it below the fan. Place on a flat surface and turn to the ON position. You are now ready to enjoy your outdoor activities. Use a dispenser for every 64 square feet (8ft x 8ft) of patio or deck. Replace after 14 days of continuous use, or when fragrance diminishes.
