**FIRST AID:**



- GENERAL DIRECTIONS:**
- Maintain pool water in the pH range 7.2 to 7.8. Adjust pH to 7.2 for severe algae.
  - Ensure that filtration system is working properly and that the filtration cycle is adequate.
  - A regular brushing program will assist in the removal of stubborn algae.
  - Calculate the volume of NAVA 90 Day Algaecide required for your pool.
  - Add NAVA 90 Day Algaecide directly to the pool, distributing over as wide an area as possible.
  - While NAVA 90 Day Algaecide controls algae, it is important that adequate levels of sanitizers (chlorine) be maintained to control bacterial growth.
