DO NOT USE ON CATS

Ready to use, no dilution necessary.

- Hold tube in upright position pointing away from user's face and body. Break off tip or cut with scissors. Apply FREEDOM[®] 45 SPOT-ON FOR DOGS as follows by gently squeezing the applicator.



DO NOT USE ON CATS

- Part dog's hair between shoulder blades.



- Apply the recommended amount of solution to the skin on the dog's back between the shoulder blades. For large and extra large dogs, application of the solution to the skin directly in front of the base of the dog's tail is also required.


SEE RECOMMENDED DOSING GUIDELINES BELOW.

For dogs weighing 33lbs or less

Apply 1.5cc of FREEDOM[®] 45 SPOT-ON FOR DOG (1 tube) to the skin of the dog's back between the shoulder blades.

MINIATURE


PUPPY

For dogs weighing 33- 66lbs

Apply 1.5 cc of FREEDOM[®] 45 SPOT-ON FOR DOGS (1 tube) to the skin of the dog's back between the shoulder blades and 1.5 cc (a second tube) to the skin directly in front of the base of the dog's tail.



X-LARGE

For dogs weighing more than 66lbs

Apply 3.0 cc of FREEDOM[®] 45 SPOT-ON FOR DOGS (2 tubes) to the skin of the dog's back between the shoulder blades and 3.0 cc (another 2 tubes) to the skin directly in front of the base of the dog's tail.

FIRST AID

IF SWALLOWED:

- Call a poison control center or doctor immediately for treatment advice.
- Have person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by a poison control center or doctor.

IF ON SKIN OR CLOTHING:

- Take off contaminated clothing.
