

### PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

#### CAUTION

#### FIRST AID



#### DO NOT USE ON CATS

Ready to use, no dilution necessary.



- Hold tube in upright position pointing away from user's face and body. Break off tip or cut with scissors. Using the cc marks on the body of the applicator as a guide apply FREEDOM 45 SPOT-ON FOR DOGS™ as follows by gently squeezing the applicator.
- Part dog's hair between the shoulder blades.
- Apply the recommended amount of solution to the skin on the dog's back between the shoulder blades. SEE RECOMMENDED DOSING GUIDELINES BELOW.



Apply 1.5 cc of FREEDOM 45 SPOT-ON FOR DOGS™ to the skin of the dog's back between the shoulder blades.
