

### DO NOT USE ON CATS

Ready to use, no dilution necessary.

- Hold tube in upright position pointing away from user's face and body. Break off tip or cut with scissors. Apply LIBERTY® 50 Plus IGR Spot-On for Dogs as follows by gently squeezing the applicator.



- Part dog's hair between shoulder blades.



- Apply the recommended amount of solution to the skin on the dog's back between the shoulder blades.  
SEE RECOMMENDED DOSING GUIDELINES BELOW.

Apply 1.35 cc of LIBERTY® 50 Plus IGR Spot-On for Dogs (1 tube) to the skin of the dog's back between the shoulder blades.



### FIRST AID

#### IF SWALLOWED:
