### FIRST AID

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**IF SWALLOWED:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

**IF INHALED:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. **Leisure Time® Free Sanitizer** is effective for residential and public swimming pools and spas. Important – **Leisure Time Free Sanitizer** is incompatible with chlorinating and brominating chemical products.

**Start-Up:**

1. Remove chlorine or bromine source and disconnect feeder. Discontinue use of ionizers and electrochlorinators if present.
2. Drain existing water in spa.
3. Clean spa surface and filter.
4. Fill spa with water.
5. Have your Leisure Time Authorized Dealer check your water for proper balance.
6. After water has been balanced, add **Leisure Time Free Sanitizer** to give a concentration of 50 ppm (1 oz. of product per 150 gallons of spa water).
7. Circulate water 15 minutes, then check **Leisure Time Free Sanitizer** concentration with **Leisure Time Spa & Hot Tub Test Strips** and adjust if necessary.

### Normal Maintenance:

Every week, check **Leisure Time Free Sanitizer** concentration and pH. Adjust if necessary.

The level of **Leisure Time Free Sanitizer** should be maintained between 30 and 50 ppm. When the level of **Leisure Time Free Sanitizer** is 30 ppm or less, add enough **Leisure Time Free Sanitizer** to bring the level up to 50 ppm. The spa's level of **Leisure Time Free Sanitizer** should never be allowed to drop below 30 ppm. To raise the **Leisure Time Free Sanitizer** level 10 ppm, add 0.2 oz. per 150 gallons of spa water.
