PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS & ANIMALS - CAUTION

FIRST AID

IF IN EYES:

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
- Call a poison control center or doctor for treatment advice.

ENVIRONMENTAL HAZARDS

This product is toxic to fish. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of waste.

PHYSICAL HAZARDS

Contents under pressure. Do not use or store near heat or open flame. Do not puncture or incinerate container. Exposure to temperatures above 130° F may cause bursting.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Read entire label and apply as directed.

SHAKE WELL BEFORE USING.

For best results, use throughout the growing season to prevent buildup of insect populations. Spray plants from a distance of 3-1/2 to 4 feet using short bursts (one second). To prevent injury to plants, avoid visibly wetting the foliage.

Apply in the early morning or late evening when the air is still, treating all foliage with particular attention to the undersides of the leaves. Contact insects directly whenever possible. Repeat applications at 7 to 10 day intervals or after heavy rains. Do not apply to food crops within one day of harvest.
