

Storage and Disposal

If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain. **Container Disposal.** Nonrefillable container. **If empty:** Do not reuse this container. Place in trash or offer for recycling if available.

First Aid

Have the product container or label with you when calling a poison control center or doctor, or if going for treatment.

Application Options for Different Sizes of Dogs

PETARMOR[®] For Dogs comes in four different packages for different-sized dogs and puppies eight (8) weeks or older: * 5 to 22 lbs. * 23 to 44 lbs. * 45 to 88 lbs. * 89 to 132 lbs. If your dog weighs more than 132 lbs., discuss dosing with your veterinarian. Do not use more than one applicator per dog per month.
