- Avoid product runoff to nearby desirable plants.
- Do not apply near bodies of water including, fish pools, ponds, lakes or streams.
- Do not apply over the roots systems of desirable plants. For trees and shrubs do not apply closer than twice the distance from the trunk to the drip line as roots may be within this area.

RESTRICTIONS (Continued)

- Do not apply to slopes in landscape as movement on soil surfaces may damage desirable plants down slope.
- Do not apply next to a fence if desirable vegetation is growing on the other side, or if future planting is intended.
- Do not use before planting lawns, fruits, vegetables, flowers, or other plants because this product remains active in soil for up to one year.
- In soils with heavy clay, weed control may exceed 1 year.
- Do not use on desirable turf.

HOW TO APPLY

Measure area to be treated.

Calculating Total Area: LENGTH x WIDTH = TOTAL SQ. FT.

SPRINKLING CAN – APPLICATION DIRECTIONS

Pour 1 quart into a sprinkling can and add 1 gallon of water.

Apply evenly over 75 square feet.

Allow application to soak into ground, avoiding runoff to nearby desirable plants.
