Side effects

TO PREVENT HARM TO YOU AND YOUR DOG, READ ENTIRE LABEL AND DIRECTIONS BEFORE EACH USE. FOLLOW ALL DIRECTIONS AND PRECAUTIONARY STATEMENTS CAREFULLY. Weigh your dog to be sure you are applying the right dose formulated for the weight of your dog. Overdosing your dog can result in serious illness. Do not bathe your dog within the first 24 hours after the product has been applied. If your dog is exhibiting signs of and/or is being treated for skin problems, talk to your veterinarian before applying any topical flea and tick control product.


■ RESTRICTIONS: Do not use on dogs or puppies less than 8 weeks of age, weighing less than 5 lbs. Do not allow children to apply product. DO NOT USE ON CATS OR RABBITS. DO NOT USE ON OTHER ANIMALS. Do not allow your dog to ingest this product. Do not split tubes between dogs. Do not double-dose or apply more than one tube for dogs weighing more than 132 lbs. Do not apply more often than once every 30 days. Do not allow contact with treated area until completely dry.

To repel and kill fleas, ticks, and mosquitoes; to kill flea eggs, pupae and larvae, lice, and to aid in control of mites; to repel and prevent blood feeding by biting flies; apply only to dogs or puppies as follows:

■ APPLICATION DIRECTIONS

1. Remove one applicator from packaging. Hold applicator upright and remove cap.
2. Invert cap and place other end back onto applicator tip. Push cap down to break seal. Remove cap prior to treatment application.
3. Part dog's hair until skin is visible. Place applicator tip directly against exposed skin.
 - 3a. For use only on small dogs and puppies (8 weeks of age or older), weighing (5 to 10.9 lbs.) or weighing (11 to 22.9 lbs.)** - Deposit entire contents by squeezing the entire applicator contents onto dog's skin, at a single site, between the shoulder blades as shown in diagram 3a.

**■ FREQUENCY OF APPLICATION**

Fleas, flea eggs, flea pupae, flea larvae, ticks, and lice infestations can be controlled with monthly applications of EFFITIX® Plus Topical Solution for Dogs. Biting flies and mosquitoes are also repelled by EFFITIX® Plus Topical Solution for Dogs.

Fleas: EFFITIX® Plus Topical Solution for Dogs can start killing adult fleas within 6 hours and lasts for up to three months against adult fleas, flea eggs and flea larvae. Apply monthly if your dog has fleas that may cause flea allergy dermatitis (FAD), or if re-infestation is likely.

Ticks: EFFITIX® Plus Topical Solution for Dogs can kill ticks for at least a month. Apply monthly where tick control is consistently needed.

Lice: EFFITIX® Plus Topical Solution for Dogs can kill biting and chewing lice for up to a month. Apply monthly where lice control is consistently needed.

Mites: EFFITIX® Plus Topical Solution for Dogs aids in the control of mite infestations that may cause sarcoptic mange.
