**CAUTION:** For animal use only. Not for use on humans. Harmful if absorbed through skin or inhaled. Contact with this product may cause transitory tingling sensation. Avoid contact with skin, eyes or clothing. Avoid breathing vapors. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse.

**STATEMENT OF PRACTICAL TREATMENT. IF ON SKIN:** Wash with plenty of soap and water. Get medical attention. **IF INHALED:** Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention. **IF IN EYES:** Flush with plenty of water. To protect horses from House Flies, Face Flies, Horn Flies, Stable Flies, Black Flies, Horse Flies, Deer Flies, Lice and Ticks, and from biting gnats such as Punksies and No-see-ums. Thoroughly brush the horse's coat prior to application to remove loose dirt and debris. For best results shampoo and rinse, wait until coat is completely dry and apply Repel-X Lotion. Using protective gloves or mitt, apply a light film to spot treat areas of the horse where flies gather. May be applied around superficial wounds and abrasions. Avoid direct application to eyes, nose and mouth. Repeat application as necessary but no more often than once every 5 to 7 days. Wash hands with soap and water after use.

**STORAGE AND DISPOSAL**  
Do not contaminate water, food or feed by storage or disposal.  
**STORAGE:** Store in a cool, dry place inaccessible to children and pets.
