## FIRST AID

**SHAKE WELL BEFORE USE. USE ONLY IN A WELL VENTILATED AREA.**

**DOGS, PUPPIES, CATS, KITTENS:** Cover animal's eyes with hand and with a firm, fast stroke to get a proper spray mist, spray head, ears and chest until damp. With fingertips, rub into face and around mouth, nose and eyes. Next spray neck, middle and hindquarters, finishing legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On long haired animals, rub your hand against the lay of hair, spraying the ruffled hair directly behind the hand. Make sure spray thoroughly wets ticks. Allow ADAMS™ WATER-BASED FLEA & TICK MIST to remain on animal for 5 minutes, then towel dry, brush and comb to remove dead fleas and ticks. Do not reapply product for one week.

## STORAGE AND DISPOSAL

**STORAGE:** Store in a cool, dry area away from heat and open flame. Do not contaminate water, food or feed by storage or disposal. Do not transfer contents to other containers.
