Bio Spot Defense Spot On Flea & Tick Control for Dogs prevents flea eggs from developing into adult fleas for up to 2.5 months. Bio Spot Defense Spot On Flea & Tick Control for Dogs also kills fleas and ticks for 3 weeks and kills and repels mosquitoes for 3 to 4 weeks.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Bio Spot Defense Spot On Flea & Tick Control for Dogs works by application directly to the dog's skin, not to the hair. When applying, manually push aside dog's hair to allow direct application to the skin. Do not get this product in dog's eyes or mouth.

Note: Each package contains sufficient applicators for 6 applications.

FOR EXTRA LARGE SIZE DOGS

1. Bend at perforation and tear off first applicator.
2. Hold applicator and bend area of plastic at perforation, tear off and discard. Hold applicator upright and snap tip back, away from face and body.
3. The dog should be standing for easy application. Apply Bio Spot Defense Spot On Flea & Tick Control for Dogs evenly to four or five spots on the top of the back from the shoulder to the base of the tail. At each spot, part the hair until the skin is visible. Place the tip of the tube on the skin and gently squeeze to expel a portion of the solution on the skin. Do not apply an excessive amount of the solution at any one spot that could cause some of the solution to run off the side of the dog.
4. Do not spread Bio Spot Defense Spot On Flea & Tick Control for Dogs by hand over the dog. Although the dog's skin and hair oils will naturally distribute the application over the entire dog, brushing the dog 12-24 hours after application will help to distribute the material over the skin.
5. Do not reapply product for 30 days unless re-treatment is required, but not sooner than 8 days after the initial treatment. Do not retreat more than once per month.
6. Discard empty applicator as described in Storage and Disposal.

Bio Spot Defense Spot On Flea & Tick Control for Dogs is most effective when used as part of a total flea and tick management program. Use other Bio Spot products registered for residential area control of these pests in conjunction with this treatment. Monthly treatments are required for optimal control and prevention of fleas.

The successive feeding activity of fleas on pets may elicit a hypersensitivity skin disorder known as flea allergy dermatitis (FAD). Treatment of pets with Bio Spot Defense Spot On Flea & Tick Control for Dogs rapidly kills fleas and may reduce the incidence of this condition.

Bio Spot Defense Spot On Flea & Tick Control for Dogs is water resistant and remains efficacious following exposure to rainfall or swimming.
