

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR HORSES USE FULL STRENGTH: This non-oily insecticide repellent may be applied with a trigger spray applicator or as a wipe. Kills and repels stable flies, horse flies, face flies, deer flies, house flies, horn flies, mosquitoes, gnats and ticks. Do not use on foals under 3 months of age.

DIRECTIONS FOR TRIGGER SPRAY USE: Remove excess dirt and dust. Apply light spray mist to coat while brushing lightly against lay of the hair. Avoid spray in eyes and mucous membranes. Apply with sponge or cloth to those areas.

DIRECTIONS FOR WIPE-ON USE: Thoroughly brush horse to remove excess dirt and dust. Extremely dirty horses should be shampooed, rinsed and allowed to dry before applying wipe. Use a sponge, clean soft cloth, or mitt. Apply liberally over areas to be protected. Pay special attention to legs, belly, shoulders, neck, and facial areas. Avoid eyes and mucous membranes.
