FIRST AID

If In Eyes



DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Wet the animal thoroughly with warm water. Apply 1-2 tablespoons (15-30 milliliters) of Adams™ Flea & Tick Cleansing Shampoo for Cats to various parts of the hair coat. Rub to produce abundant lather. Add more water if necessary to increase lathering.

To kill fleas, ticks and lice, let lather remain in hair coat for five minutes. Work lather into outer ear if ticks are present. Rinse hair coat with clean water. Repeat every 7 to 14 days.
