

**HORSE:** Long-lasting, 12 hour effective protection from flies and mosquitoes. Won't damage saddle or bridle.  
**RIDER:** Long-lasting, 12 hour effective protection from mosquitoes and ticks including mosquitoes carrying West Nile Virus. Repels biting flies, stable flies, black flies, gnats, chiggers and sand flies for up to 8 hours. Won't damage plastics or other synthetic materials.

**DIRECTIONS FOR USE:**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Follow these guidelines when applying Centaura™ Insect Repellent for Horse and Rider.

**HORSE AND RIDER:**

- Hold 4-6 inches from body while spraying, keeping nozzle pointed away from face. Slightly moisten skin or hair coat with a slow sweeping motion.
- Excessive amounts or frequent reapplication is unnecessary.
- Do not spray directly on face.
- Apply on face by first spraying small amounts in palms of hands and spreading on face and neck, avoiding eyes.
- Do not apply to the hands of small children.
- When using on children, apply to your hands and then apply it to your child. Do not apply to their hands. To apply to a child's face and neck, apply the product into your hands and apply to the child. Take care to avoid mouth and eyes and apply sparingly around ears. Do not allow children to handle the product.
- Avoid contact with lips, cuts, wounds, or irritated skin.
- Do not apply to excessively sunburned skin.
- Do not exceed two applications per day.

**HORSE:** Not for use on horses intended for human consumption. Do not apply under the saddle.

**RIDER:** Do not apply under clothing. Apply sparingly around ears.

**PRECAUTIONARY STATEMENTS  
HAZARDS TO HUMANS AND HORSES**

Avoid contact with eyes and mucous membranes. Causes moderate eye irritation. Wash thoroughly with soap and water after handling, returning indoors, and before eating, drinking, chewing gum, or using tobacco.

The information below describes the first aid procedures for incidents involving Centaura™ Insect Repellent for Horse and Rider:

**FIRST AID**

<b>IF IN EYES</b>	<ul style="list-style-type: none"><li>• Hold eye open and rinse gently with water for 15-20 minutes. Remove contact lenses, if present, after the first five minutes, then continue rinsing.</li><li>• Call a poison control center or doctor for treatment advice.</li></ul>
<b>IF SWALLOWED</b>	<ul style="list-style-type: none"><li>• Call a physician or poison control center immediately for treatment advice.</li><li>• Have person sip a glass of water if able to swallow.</li><li>• Do not induce vomiting unless told to do so by a Poison Control Center or a doctor.</li><li>• Do not give anything to an unconscious person.</li></ul>

Have the product container or label with you when calling a poison control center or doctor, or going for treatment. In case of emergency call: 800-234-2269

**PHYSICAL HAZARDS**

Flammable. Do not use or store near heat sources, sparks or open flame. Do not smoke while applying.

**STORAGE & DISPOSAL**

Store in a cool, dry place out of the reach of children. Keep away from heat, sparks and open flame. Container is under pressure. Protect product container from direct sunlight and from temperatures above 122°F (50°C). **IF EMPTY:** Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. **IF PARTLY FILLED:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
