 1. Remove one applicator tube from the package and hold in an upright position pointed away from your face.  
 2. Twist dispensing tip clockwise about 1/2 turn while pushing down to break the tube's seal. Do not remove the dispensing tip.  
 3. Position the dispensing tip on the dog's back between the shoulder blades. Use the dispensing tip of the tube to part the dog's hair so that the product will be applied at skin level. Begin squeezing out the contents of the tube as you move from the shoulder blades along the dog's back to the base of the tail.  
 4. Repeat every month. Do not bathe your dog 48 hours prior to application.  
 5. Separate treated dog from other pets for 24 hours after treatment has been applied.  
**STORAGE AND DISPOSAL**  
 Do not contaminate water, food, or feed by storage and disposal. **PESTICIDE STORAGE:** Keep this product in its tightly closed original container, when not in use.
