DOG & CAT REPELLENT OUTDOOR GRANULAR REPELLENT

A training aid for your own pet. Will repel dogs and cats for up to 24 hours when applied daily. Keeps pets away from trees, shrubs, garbage cans/bags and other "forbidden areas". Reduces the frequency of defecation and urination by dogs on lawns and flower gardens. Reduces frequency of digging by cats in flower gardens.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS – CAUTION

Harmful if absorbed through skin. Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. FIRST AID

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

USE RESTRICTIONS

For outdoor use only. Do not allow persons or pets to enter the treated area until dusts have settled. Do not apply this product in a way that will contact any person or pet, either directly or through drift. Keep people and pets out of the treated area during application. Do not apply directly to foliage of shrubs or to ornamental, soft-bodied plants. Do not apply to food or feed crops.

User Safety Recommendations: Users should wash hands before eating, drinking, using tobacco or using the toilet. Users should remove clothing immediately if pesticide gets inside or on clothing. Then wash thoroughly with detergent and hot water separately from other laundry and put on clean clothing. Wash the outside of gloves before removing. OUTDOOR USE: Keeps pets away from trees, shrubs, garbage cans/bags and other "forbidden areas". Reduces the frequency of defecation and urination by dogs on lawns and flower gardens. Reduces the frequency of digging by cats in flower gardens.

NOTE: This product is not likely to break the established urination patterns of dogs unless it is used as a training aid.

PRE-TREATMENT DIRECTIONS: Stray animals are frequently attracted to areas where pets have soiled with feces or urine. To discourage repeat visits, remove any droppings and clean with water.

APPLICATION DIRECTIONS: Lightly sprinkle granules directly from the container or use a spreader at the rate of 1 lb. per 250 sq. ft. Apply as a border to the item to be protected.

RE-TREATMENT DIRECTIONS: Repeat daily, or as necessary, until undesirable habit is broken.

STORAGE AND DISPOSAL

PESTICIDE STORAGE: Store only in the original container in a cool, dry place inaccessible to children and pets.

PESTICIDE DISPOSAL: *If partly filled* -- Call your local solid waste agency for disposal instructions. Do not place unused product down any indoor or outdoor drain.
