General Information

Acceleron DX-709 provides seed and seedling protection against seedborne fungi causing seed decay and soilborne pathogens, *Rhizoctonia solani* and *Fusarium* spp. Apply as a seed treatment using standard slurry or mist-type seed treatment equipment. Uniform application of seed is necessary to ensure seed safety and best disease protection. Seed should be sound and well cured prior to treatment. Product should be diluted with sufficient water to ensure complete seed coverage. Consult a seed treatment specialist regarding slurry rates recommended for the crop to be treated with Acceleron DX-709. The length of control will vary depending on the rate used.

Use Restriction

Do not use treated seed for food, feed, or oil processing.

Use Precaution

Field corn: Apply at a product rate of 0.32 – 0.64 fl.oz. per 100 lbs. of seed.

Areas planted with treated seed may be replanted immediately with any crop for which a tolerance exists for trifloxystrobin. Do not plant any crop without trifloxystrobin tolerances until 30 days after planting trifloxystrobin treated seed.
