### FIRST AID:

**WHY YOU SHOULD USE THIS PRODUCT:** This product is a dual action sanitizer and shock that is convenient, easy to use, and won't over-stabilize your pool.

For crystal clear pool water, follow our 4 step pool care program: **Step 1.** Test and adjust pool water balance, **Step 2.** Chlorinate and clarify, **Step 3.** Shock treat once a week, and **Step 4.** Add algaecide routinely as needed.

Additional shocking to keep water clean and clear is recommended after: rain and heavy winds, high number of swimmers, increased water temperature, increased frequency of pool usage.

**DIRECTIONS FOR USE:** It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**READ ALL PRECAUTIONARY STATEMENTS BEFORE USE.**

Note: This product degrades with age. Use a chlorine test kit and increase dosage, as necessary, to obtain the required level of available chlorine.

**SWIMMING POOL WATER DISINFECTION:** For a new pool or spring start-up, superchlorinate with 58 to 116 fl. oz. of product for each 10,000 gallons of water to yield 5 to 10 parts per million (ppm) of available chlorine by weight. Check the level of available chlorine with a test kit. Adjust and maintain pool water pH between 7.2 - 7.6. Adjust and maintain the alkalinity of the pool to between 60 to 120 ppm.

To maintain the pool, add manually or by a feeder device 40 fl. oz. of this product for each 10,000 gallons of water to yield an available chlorine residual between 2 to 4 ppm by weight. Stabilized pools should maintain a residual of 1 to 4 ppm available chlorine. Test the pH, available chlorine residual and alkalinity of the water frequently with appropriate test kits. Frequency of water treatment will depend on temperature and number of swimmers.

Every 7 days, or as necessary, superchlorinate the pool with 58 to 116 fl. oz. of product for each 10,000 gallons of water to yield 5 to 10 ppm available chlorine. Check the level of available chlorine with a test kit. Do not reenter pool until the chlorine residual is between 1 to 4 ppm.
