HOW TO APPLY

- Shake well before using. Connect sprayer to hose. Turn on water.
- To begin spraying, point nozzle in the direction you want to spray. Bend small yellow plastic tab on side of sprayer back and turn knob clockwise to ON position.
- Spray evenly over measured area.
- To stop spraying, bend small yellow plastic tab back and turn knob counter clockwise to OFF position. Turn off water.
- Relieve water pressure by bending plastic tab back and turning knob to ON position until water slows to a drip. Then turn knob back to OFF position.
- Disconnect sprayer from hose.

AMOUNT TO APPLY

Apply only the recommended amount for the area to be covered. Exceeding recommended rates may damage turf.

- **WARM SEASON LAWNS** - bahia, common Bermuda, centipede, zoysia and St. Augustine (EXCEPT FLORATAM)
1 quart covers 5,000 sq ft.

NOTE: Some temporary injury may occur with these lawns. DO NOT USE ON Floratam, a variety of St. Augustine-grass widely grown in Florida, as damage may occur. In spring, do not apply until grass has reached full green up. In fall, do not use when grass is going into dormancy. Some hybrid Bermuda grasses may be sensitive to this product.

- **COOL SEASON LAWNS** - bentgrass, bluegrass, fescue and ryegrass: **1 quart covers 3,300 sq ft.**


NOTE: When applying to bentgrass, grass height should be 1 1/2" or more.

FOR BEST RESULTS

- If lawn needs watering, water thoroughly 24 hours before application.
- Do not cut grass 1 to 2 days after application.
- Do not water for 48 hours after application as watering will wash off weed killing material.
- Spray when air is calm to avoid spray drift that might injure desirable ornamental plants.
- Do not apply when temperatures exceed 85°F.
- Do not reseed, sod or plug lawns, or plant stolons for 3 to 4 weeks after use. Do not apply to newly seeded lawns until they have been mowed three times.
- Spray when weeds are actively growing.
- Weeds will begin to curl within a few days. Some hard-to-control weeds may require a repeat application in 3 to 4 weeks.

IMPORTANT

For grass lawns only. Do not spray Buffalograss, dichondra, lippia or desirable clovers. Do not use this product on flower or vegetable beds, or around shrubs, trees or ornamental plantings. The maximum number of broadcast applications per treatment site is 2 per year.



WEEDS CONTROLLED

Buckhorn, chickweed, clover, dandelion, ground ivy, henbit, knotweed, lambsquarters, oxalis, pigweed, plantain, poison ivy, ragweed, spurge and many other broadleaf weeds.
