



Hold applicator upright away from face and body and use scissors to cut secure seal applicator tip. Prior to application of the product, gently lift the cat's or kitten's hair coat on the back of the neck at the base of the skull, position the tip of the applicator on the cat's exposed skin and squeeze out the entire contents of the applicator onto the cat's skin.
