This product contains Etofenprox which kills biting adult fleas, deer ticks, and mosquitoes your cat may acquire from its surroundings. It also contains an insect growth regulator (IGR), (S)-Methoprene, which prevents flea eggs from maturing into biting adults.

**DIRECTIONS FOR USE:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product contains 8 applicators, each 1.8cc (one monthly dose). Do not apply more than once every month.

**USE ONLY ON CATS AND KITTENS 12 WEEKS OF AGE AND OLDER.**

Do not get this product in your cat's eyes or mouth.

Bend at perforation and tear off 1st month's applicator. Hold applicator upright and bend numbered area of plastic at perforation, tear off and discard. Hold applicator upright away from face and body and use scissors to cut secure seal applicator tip. Prior to application of the product, gently lift the cat's hair coat on the back of the neck at the base of the skull, position the tip of the applicator on the cat's exposed skin and squeeze out the entire contents of the applicator onto the cat's skin.
