DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Hold 4 to 6 inches from skin while spraying, keeping nozzle pointed away from face. Slightly moisten skin. Excessive amounts or more frequent reapplication should be unnecessary. Do not apply over cuts, wounds or irritated skin. Do not apply near eyes and mouth. Apply sparingly around ears. When using on children, apply to your own hands and then put it on the child. Use just enough repellent to cover exposed skin. Do not use under clothing.
