It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Tear open package beginning at the notch. Gently pull the top towelette out of the pouch. Towelettes should be pulled at an angle to dispense one at a time. Reseal the pouch to prevent the wipes from drying out between uses.

Unfold towelette and wipe evenly over exposed skin. Excessive amounts should be unnecessary. Do not apply over cuts, wounds or irritated skin. Do not apply near eyes and mouth. Apply sparingly around ears. When using on children, apply to your own hands and then put it on the child. Use just enough repellent to cover exposed skin. Do not use under clothing. Avoid overapplication of this product. Do not apply more than three times per day. After returning indoors, wash treated skin with soap and water. Wash treated clothing before wearing it again.

**WHEN USING PRODUCT ON CHILDREN:** Do not apply to their hands. To apply to child's face and neck, wipe the product onto your hands and apply to the child. Take care to avoid mouth and eyes, and apply sparingly around their ears. Do not allow children to handle the product.
