


PRODUCT INFORMATION

The successive feeding activity of fleas on pets may elicit a hypersensitivity skin disorder known as flea allergy dermatitis (FAD). Treatment of cats with DefenseCare™ Flea Protection Large Cat kills fleas and may reduce the incidence of this condition.

DefenseCare™ Flea Protection Large Cat kills fleas on cats within 12 hours. Reinfesting fleas are killed within 2 hours with protection against further flea infestation lasting for up to four (4) weeks. Pre-existing pupae in the environment may continue to emerge for six (6) weeks or longer depending upon the climatic conditions.

Larval flea stages in the cat's surroundings are killed following contact with a DefenseCare™ Flea Protection Large Cat treated cat.

DefenseCare™ Flea Protection Large Cat is waterproof and remains effective following a shampoo treatment, swimming or after exposure to rain or sunlight.

Monthly treatments are required for optimal control and prevention of fleas.
