DIRECTIONS FOR USE (continued)
This product must not be used to clean the following food contact surfaces: utensils, glassware and dishes.
MILDEWSTATIC INSTRUCTIONS: Will effectively control the growth of mold and mildew plus the odors caused by them when applied to hard, nonporous surfaces such as walls, floors, and table tops. Apply use-solution of 1/2 oz. per gallon of water with a cloth, mop, sponge, or coarse spray. Make sure to wet all surfaces completely. Let air dry. Repeat application weekly or when growth reappears. **FUNGICIDAL DIRECTIONS:** For use in areas such as locker rooms, dressing rooms, shower and bath areas and exercise facilities follow disinfection directions. **TOILET BOWLS:** Swab bowl with brush to remove heavy soil prior to cleaning or disinfecting.
