The Directions for Use of this product must be followed carefully. It is impossible to eliminate all risks inherently associated with the use of this product.

Do not apply this product in a way that will contact workers or other persons either directly or through drift. Only protected handlers may be in the area during application.

Application is prohibited directly into sewers or drains or to any area like a gutter where drainage to sewers, storm drains, water bodies or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

#### Treatment of Preconstruction Lumber and Logs

##### General Information

Timbertreat® ICP-5 must be diluted before use. To prepare the spray, dilute Timbertreat® ICP-5 as shown in the following spray dilution chart:

#### Directions for Application

To protect unseasoned and seasoned lumber and logs from wood destroying insects, such as termites, Carpenter ants and beetles (ambrosia, powder-post, old house borers and others), totally treat wood with up to a 0.5% to 1.0% solution of Timbertreat® ICP-5 insecticide. This solution can be applied by various methods including spraying, brushing, dipping, or pressure treatment. Frequent monitoring of dip and pressure systems are necessary to insure that the desired level of Timbertreat® ICP-5 is maintained. Wood can be handled after treatment when dry.

**For dip treatments**, the wood should be totally submerged in the solution until thoroughly wet and then allowed to dry in a suitable location. Dipping solutions to which Timbertreat® ICP-5 has been added should be agitated before use if left unused for long periods of time. Sediment, debris, and other deposits should be periodically cleaned from tank.

**Pressure treatments**, the wood should be placed in the treatment chamber, the Timbertreat® ICP-5 solution added to the system pressurized up to 250 psi for up to one hour depending on the density and type of wood treatment. The target permethrin retention in wood is 500 to 1,000 ppm in the top 0.5 inch of wood or a loading of 0.0175 to 0.035 pounds permethrin/cubic foot of wood. After the pressure is released and the system drained, the wood should be placed in a suitable location for drying.

**For spray treatments**, the wood should be sprayed thoroughly including back and ends.

**For brush treatment**, all parts of wood surfaces should be thoroughly treated.

## STORAGE AND DISPOSAL

Do not contaminate other pesticides, fertilizers, water, food or feed by storage or disposal

#### Storage

Do not store below 10°F, (-12°C)

Do not use or store near open flame or hot surfaces.

Keep out of reach of children and animals. Store in original containers only. Store in a cool dry place and avoid excess heat. Carefully open containers. After partial use, replace lids and close tightly. Do not put concentrate or dilute material into food or drink containers. In case of a spill, avoid contact, isolate and keep out animals and unprotected persons. Confine spills. Call Chemtrec at 1-800-424-9300.

**To confine spill:** If liquid, dike surrounding area and absorb with sand, cat litter or commercial clay. If dry material, cover to prevent dispersal. Place damaged package in a holding container. Identify contents.

#### Pesticide Disposal

Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. #### Container Disposal

**Metal or Plastic Container: Non-refillable container:** Do not reuse or refill this container. Triple rinse as follows: Empty the remaining contents into application equipment or mix tank and drain for 10 seconds after flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds, pour rinsate into application equipment or mix tank or store rinsate for later use or disposal. Drain for 10 seconds after flow begins to drip. Repeat this procedure two more times. Then offer for recycling if available, or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Do not cut or weld metal containers.
