**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.  
**READ THIS LABEL:** Read this entire label and follow all use directions and use precautions.

**USE RESTRICTIONS:** THIS IS NOT A TAMPER RESISTANT BAIT STATION. DO NOT USE THIS PRODUCT IN AREAS ACCESSIBLE TO CHILDREN, PETS, DOMESTIC ANIMALS OR NONTARGET WILDLIFE. DO NOT USE THIS PRODUCT OUTDOORS.

Use only to control house mice in homes. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food.

**SELECTION OF TREATMENT AREAS** Determine areas where mice will most likely find and consume the bait. Generally, these areas are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where mice or their signs have been observed.

**HOUSE MICE**

1. Remove this product from the carton.
2. Placement: Can be used in a horizontal or vertical position. Station can be placed flat or on its side with entrance holes exposed.

For best performance, use this product spaced 8 to 12 feet apart along walls where mice or their signs have been seen.

Replace bait station when contents are consumed. Replace bait station if station is damaged and the bait is exposed. If bait is not touched after 3 days it should be moved to a new location where mouse activity is evident. Wearing gloves, collect and dispose of all dead animals and leftover bait properly, as specified on this label. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation does occur, repeat treatment.

**PRECAUTIONARY STATEMENTS:**

**HAZARDS TO HUMANS AND DOMESTIC ANIMALS**

**CAUTION:** May be harmful or fatal if swallowed. Keep away from humans, domestic animals, and pets. Wear gloves when handling bait station or animals. Wash hands with soap and water after handling bait station. IF BAIT IS EATEN BY ANIMALS OR PETS, CALL A VETERINARIAN AT ONCE.

**FIRST AID**

**NOTE TO PHYSICIAN AND VETERINARIAN**

This product may reduce the clotting ability of the blood and cause hemorrhaging. If poisoning occurs, intramuscular and oral administration of Vitamin K1 are indicated, as in poisoning from overdose of bishydroxycoumarin. **FOR HUMAN CASES:** Vitamin K1 is antidotal at doses of 10 to 20 mg (not mg/kg). **FOR ANIMAL CASES:** Vitamin K1 is antidotal at 2-5 mg/kg intramuscularly. Repeated doses may need to be given for up to 2 weeks (based on monitoring of prothrombin times). In severe cases, blood transfusions may be necessary.

**ENVIRONMENTAL HAZARDS:** This product is toxic to fish, birds and wildlife. Predatory and scavenging mammals and birds might be poisoned if they feed upon animals that have eaten the bait. Do not apply directly to water.

**STORAGE AND DISPOSAL**

This is a non-refillable container. Do not reuse or refill this container.

**PESTICIDE STORAGE:** Store in original container in a dry place inaccessible to children and pets.




