FIRST AID

IF IN EYES: Hold eye open and rinse slowly and gently with water for 20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for advice.

IF SWALLOWED: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything to an unconscious person.

USE INFORMATION

Cleanwater Blue™ is used to control algae and to suppress nonpublic health bacteria and bacteria that cause odor problems in residential spas and hot tubs.

SPECIFIC DIRECTIONS FOR USE

To control algae and nonpublic health bacteria and bacteria that causes odor problems in residential spas and hot tubs:

For Spas and Hot Tubs: Apply at the rate of 6 mL of Cleanwater Blue™ per 100 gallons of water using supplied measuring cup.

This dosage will yield a rate of 0.9 ppm metallic copper. Treated pool effluent should not be discharged where it will drain into lakes, streams, ponds or public water. Application should be made before visible algae appear.

Every 14 Days: Test the copper level using a standard commercial swimming pool or spa copper test kit. Add Cleanwater Blue™ to raise level back to 0.9 ppm (see table). The amount of Cleanwater Blue™ to be added is proportional to the starting concentration and volume of water. Do not exceed 1.0 ppm metallic copper.

APPLICATION AND HANDLING EQUIPMENT

Never use mild steel, nylon, brass or copper around Cleanwater Blue™. Always rinse and clean equipment thoroughly each night with plenty of fresh, clean water.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in a safe place away from pets and keep out of the reach of children. Store away from excessive heat. Cleanwater Blue™ will freeze. Always store Cleanwater Blue™ above 32 degrees F (Do not Freeze). Freezing may cause product separation. Always keep container closed. Store Cleanwater Blue™ in its original container only. Keep away from galvanized pipe, and any nylon storage or handling equipment.

DISPOSAL
