

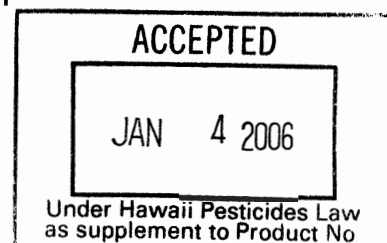

DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

Crop/Site/Commodity: For use in or on contained plastic bait traps, fiberboard blocks, or similar dispensers, telephone or light poles or other inanimate objects, or non-food tree trunks or limbs. All baits shall be placed out of the reach of children and pets.

Target Pest/Problem: Multiple species of tephritid fruit flies.

Dosage: Apply up to 25 milliliters of mixture to approximately 6 square inches on fiberboard blocks, non-food tree trunks or limbs, or other inanimate objects, or on cotton wicks or other absorbent materials in contained traps.

Mixing Directions: Add up to 23 fluid ounces of Dibrom Concentrate to three (3) quarts of Cue-lure (for melon flies) or Methyl Eugenol (for Oriental fruit flies). Add Min-U-Gel, if needed, to achieve the desired consistency. **Note:** Min-U-Gel must be added last.

Frequency/Timing of Application: Apply up to 600 bait traps per square mile. Applications may be repeated every 2 to 4 weeks until the infestation is reduced to acceptable levels.

Other Restrictions and Requirements:

- Methyl eugenol is known to attract native flies of the family Drosophilidae. Therefore, do not apply within ½ mile of native or mixed native forested areas without first consulting with the Hawaii Department of Land and Natural Resources, Division of Forestry and Wildlife office for guidance.
- Do not apply to any item that may be used for food or feed.
- Permission from the property owner or manager must be obtained prior to application.
- Each bait dispenser, or object treated shall be posted identifying it as containing or being treated with a fruit fly attractant containing the insecticide Dibrom[®] and a contact phone number.

This 24(c) registration is valid until or until otherwise withdrawn, cancelled or suspended by the United States Environmental Protection Agency (USEPA), the manufacturer, the 24(c) registrant or the Hawaii Department of Agriculture.

All applicable directions, restrictions, and precautions on the USEPA-registered label must be followed.

This labeling must be in the possession of the user at the time of pesticide application.

Neither the Hawaii Department of Agriculture, the manufacturer or formulator makes any warranty of merchantability, fitness of purpose, or otherwise, expressed or implied, concerning the use of a pesticide in accordance with these provisions.
