Directions for Use

General Information

GoalTender provides preemergence control of many broadleaf and grass weeds during the establishment of sugarcane, including Aiea morningglory, guineagrass and triazine-resistant swollen fingergrass.

Rates and Method of Application

Apply 1/2 to 4 pints per acre (0.25 to 2.0 lbs. active) as a broadcast spray before sugarcane shoot leaves unfurl. The lowest rate can be used prior to weed emergence when the soil is moist. Most drip-irrigated fields will require 1-2 pints per acre (0.5 to 1.0 lbs. active). Use higher rates for preemergence control in dry weather and to control emerged weeds.

Apply 1/2 to 4 pints per acre (0.25 to 2.0 lbs. active) as a directed spray after the sugarcane leaves have unfurled. Avoid contact with the leaves of the sugarcane or crop damage will result.

GoalTender can also be used in combination with glyphosate as a directed spray field edge application if emerged weeds are present.

GoalTender herbicide should be thoroughly mixed with clean water at recommended concentration and applied using a low-pressure ground sprayer equipped in a minimum spray volume of 20 gallons per acre.

If spray drift or treated soil come into contact with emerging sugarcane spikes or whorls, crop injury may occur. The crop will outgrow this temporary injury, and the effect generally is offset by the benefit of weed control.

Weeds Controlled

GoalTender herbicide will provide preemergence control/suppression of the following weeds when applied at the recommended dosage:

Aiea morningglory
guineagrass
swollen fingergrass

Crop-Specific Use Restrictions

The following use restrictions must be observed when GoalTender herbicide is used as recommended on this label:

- Follow the General Use Restrictions on the EPA-registered label.
- For wind speeds at or below 10 mph, see package label for spray drift precautions.

- For wind speeds between 10-20 mph, **do not apply this product in a manner that allows spray to drift from the application target site and cause harm to humans, animals or other non-target sites.** Recommended applications to reduce off-site drift include, but are not limited to, the following:
 - Apply by ground boom with nozzle height no more than 2 feet above ground for broadcast applications or no more than 1.25 foot above the ground for directed sprays,
 - Use coarse spray according to ASAE 572 definition for standard nozzles or VMD of 475 microns for spinning atomizer nozzles.
 - Use hooded or shielded sprayers or other means to reduce drift.
 - Use spray drift retardants and/or other measures known to control drift.
- This labeling must be in the possession of the user at the time of application.
- For use on non-bearing sugarcane only.
- Do not apply more than 8 pints GoalTender per acre (4 lbs. active) per crop as result of multiple applications.
- **Preharvest Interval:** Do not harvest for food or feed within one year of application.
- Do not apply more than a total of 4.0 lbs. of oxyfluorfen active ingredient per acre per year.
- Avoid contact with the leaves of the sugarcane or crop damage will result.
- **Chemigation:** Do not apply this product through any type of irrigation system for uses described in this supplemental labeling.
- **Do not harvest for food or feed within one year of application.**
