- 1) Do not apply more than 16 fl. oz./A/season of Tilt.
- 2) Do not apply within 3 days of harvest for grain
- 3) Do not apply more than 0.45 lb. a.i. propiconazole containing products/A/season.
- 4) This is a nonfood use, and as such, no portion of the plant may be grazed, used or distributed for food or feed purposes. This restriction pertains to, but is not limited to, green chop, hay, pellets, meal, whole seed, cracked seed, roots, bulbs, leaves and seed screenings, and to the grazing of the crop field, stubble or regrowth.
- 5) All seed grown from crops treated under this registration shall bear a tag or container label, which forbids use of the seed for human consumption or animal feed.
- 6) All seed screenings shall be disposed of in such a way that they cannot be distributed or used for human consumption or animal feed.
