<b>House Bill No. 1260</b>	<ul style="list-style-type: none"><li>House Bill No. 1260, HD1, SD1, proposes to abolish HIOSH with the exception of the Boiler and Elevator Branch (B&amp;E) and Hoisting Machine Operators Advisory Board (HMOAB), effective October 1, 2010.</li><li>The Governor's budget funds HIOSH, including B&amp;E and HMOAB. The House supports the Governor's budget. The Senate is opposed.</li><li>The Senate Ways and Means Committee seeks to abolish HIOSH and transfer the functions to the federal government.</li></ul>	Motion was made to send a letter to the Senate as a committee. Members will email letter template drafts for members to use either for themselves or for their organization's president.
