

**State Procurement Office**  
**Nonprofit Organizations Qualified to Participate**  
**in Cooperative Purchasing with the State**

September 2008

Pursuant to Section 103D-804, Hawaii Revised Statutes (HRS), and Chapter 3-128-4, Hawaii Administrative Rules (HAR) nonprofit organizations with purchase of health and human service contracts procured pursuant to Chapter 103F, HRS, may participate in cooperative purchasing agreements with the State. This means qualifying organizations may purchase from State Procurement Office price and vendor lists upon:

- 1-Submission of an application by the nonprofit organization;
- 2-Approval by the Chief Procurement Officer; and
- 3-Mutual agreement between the nonprofit organization and the vendor.

Note that contact information is only as current as the organization has provided. This list will be updated as needed. The most current list, addition information about the program and the application form are available on the web at <http://hawaii.gov/spo>, click "Health and Human Services," then "For Private Providers", "SPO Programs Available to Qualifying Nonprofit Organizations" and "Cooperative Purchasing Program."
