STATE PROCUREMENT OFFICE NOTICE & REQUEST FOR SOLE SOURCE

Pursuant to §103D-306, HRS, and Subchapter 9, Chapter 3-122, HAR, the Department requests sole source approval to purchase the following:

3. Description of goods, services, or construction:
 Web Trak is an internet based subscription service which will provide Honolulu International Airport's local community with the ability to perform flight track investigation tied to aircraft noise information, and report complaints online directly into the airport's existing noise monitoring system. Web Trak is the single most effective way for airports to improve their communication of flight and aircraft noise data to the general public. It will significantly lessen the work load of Airport staff who had to investigate aircraft noise complaints from the public. Web Trak allows the local community and other key stakeholders to access flight track and aircraft noise information online. They will see actual aircraft flight movements and noise levels on the web. Web Trak by educating the community with regard to flight track and noise data reduces the need and time for Airport employees to explain where aircraft actually fly and what the noise level is. Web Trak will enhance community relations by fostering a more open dialogue and improving the perception of the Airport to the public. The 2008 Legislature has appropriated \$100,000 to be used for such consultant services.

8. Feature: The good, service, or construction has the following unique features, characteristics, or capabilities: The Department of Transportation Airports Division's (DOTA) current noise monitoring system components were manufactured by Lochard, Inc. DOTA is also utilizing Lochard's ANOMS 8 operating system and has contracted Lochard to perform the maintenance on the system. Because Lochard already has the aircraft noise component and the hardware and software that is used by DOTA to provide the noise data to the community, they have a decided edge. Other firms would have a decided disadvantage in their service. Other firms are able to supply the flight track information to the community, but do not have the noise data to correlate the flights to the noise event.

9. Essential features. How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work: Web Trak will allow the community to access the aircraft flights and noise data by self service. This will lessen the workload of the DOTA staff which were responding to inquiries. Currently, there is no staff positions dedicated to noise monitoring. Airports at San Francisco, Seattle, Long Beach and Oakland have full time noise staff. But they also subscribe to Lochard's Web Trak service to lessen the workload of their staff and promote a better community relationship. Lochard already has installed the aircraft noise component of Web Trak for DOTA and is maintaining the noise monitoring system. Other vendors would have to contract Lochard to use their noise data.

11. Alternate source. The following other possible sources for the good, service, or construction were investigated but do not meet our needs because: Other providers such as, Bridgenet and Passur have services which would cost more, because they do not have the ability to provide the noise data as Lochard can. They would have to contract Lochard to obtain the aircraft noise portion of the website or install their own noise monitors.



16. Chief Procurement Officer's comments:

This approval is given based on the DOT-Airport representation that Web Trak, an internet based subscription service of Lochard, Inc. is the only vendor that supplies all of the internet based services that is required such as noise events data, flight track data, real-time usage reports and trend analysis. Other vendors do not provide the comprehensive services required.

DOT shall ensure compliance with HAR Chapter 3-122, subchapter 15 on cost or pricing data, for sole source contracts in excess of \$100,000.
