**JOINT DEPARTMENT OF TAXATION AND IRS OUTREACH
ON MOLOKAI AND IN WAIANAЕ, OAHU**

HONOLULU—The Department of Taxation and the Internal Revenue Service (IRS) will jointly offer personal assistance to taxpayers on Molokai and in Waianae, Oahu.

The services offered include answering tax questions, resolving federal and State tax issues, help with correspondence and bills from the Department of Taxation and IRS, and more!

An appointment is not necessary, but calling ahead can ensure that preliminary research is completed ahead of time. Taxpayers should bring with them all pertinent records, original and amended tax returns, all related correspondence, and photo identification for themselves (and their spouses, if applicable).

Dates (including a special Saturday date in Waianae), locations, and telephone numbers for appointments are listed below.

Thanks to the Governor's Liaison on Kauai, the IRS will also have a presence in the State Office Building in Lihue. Information regarding IRS services on Kauai also is provided below.
